For your kind intimation, certain corrections have been made in the original proposal & highlights regarding list of changes made in the proposal in Parivesh Portal is as follows:

1. **A-1(ix):** Non-forest land required for this project (in ha) has been changed from 2871.008 ha to 2948.001 ha
2. **A-3:** Details of Person Making application has been changed from Mr. Ranjan P Sah to Mr. Sanjay Mishra, General Manager, Kusmunda Area & supporting documents have been uploaded in A-3(xvii).
3. **B-1:** Previous composite proposal of Diversion/Regularisation of 402.966 ha Revenue Forest Land of Kusmunda (205.961 Ha) & Laxman (197.005 Ha) Opencast Expansion Project of M/s SECL Kusmunda Area vide Proposal No. FP/CG/MIN/22244/005 with in-principle Stage-I Forest Clearance issued by MoEF&CC vide F.No. 8-08/2018-FC dated 26.04.2018 has been linked to the present proposal.
4. **B-2.1:** Non-forest land has been changed from 2871.008 ha to 2948.001 ha
5. **B-2.2:** Non-forest land has been changed from 2871.008 ha to 2948.001 ha
6. **B-2.3:** Non-forest land has been changed from 2871.008 ha to 2948.001 ha with village-wise break-up having changed in Jatraj Village from 138.117 ha to 215.106 ha.
7. **B-2.4:** Component wise break-up having changed in Non-Forest Land from 2871.008 ha to 2948.001 ha
8. **C(iii):** Copy of Survey of India Toposheet with change in Mining Lease Boundary & Non-forest land details
9. **C(iv):** Scanned Copy of Geo-referenced map of the forest land with change in Mine Lease Boundary, Mine Leasehold Area, Mine Lease Coordinates & Non-forest land details.


11. **M-1(i)(a)** Total Area of the Mining Lease (in ha) has been changed from 2914.95 ha to 2991.943 ha due to change in non-forest land in Jatraj village (Notified as Un-surveyed village in Gazette Notification by Ministry of Coal in S.O. 861 dated 29.03.2010). Joint inspection by Revenue Authorities revealed actual land of 215.106 ha in Jatraj village instead of notified 138.117 ha (un-surveyed). Refer Tehsildar Darri Letter No. 192/The/Wa/2023 Darri dated 28.02.2023 (Copy enclosed)
12. **M-2(vi)**: Copy of detailed land use plan in 1:4000 scale prepared by using GPS or total station coordinates has been modified w.r.t 2991.943 Ha Mine Leasehold of Kusmunda OCP. Village wise break up of type of land has been updated in the Land Use Plan.
13. **M-2(vii)**: Copy of map of the outer boundary of mining lease area has been modified w.r.t. 2991.943 ha Mine Leasehold of Kusmunda OCP.
14. **M-5.2**: Estimated reserve along with accuracy & confidence level has been updated till date
15. **M-7**: Mineral Wise details have been updated till date.

जांच प्रतिवेदन

विषयान्तर्गत ग्राम जटराज (मसाहती ग्राम चन्द्रनगर) पहनं. 34 रा.नि.मं. दुरपा, तहसील दर्री जिला कोरबा (छ.ग.) एस.ई.सी.एल. कुसमुण्डा क्षेत्र द्वारा पूर्ण अर्जित ग्राम है जिसे विभिन्न चरणों में अलग-अलग वर्षों में अर्जन किया गया है। अर्जन के समय ग्राम जटराज एक मसाहती ग्राम था। ग्राम जटराज (मसाहती ग्राम चन्द्रनगर) का पुराने उपलब्ध राजस्व अभिलेखों का अवलोकन करने से कुल भौगोलिक क्षेत्रफल में भिन्नता पाया गया।

मसाहती मिसल खसरा अभिलेख वर्ष 1928-29 में कुल खसरा 94 कुल रकबा 199.54 एकड़ भूमि होना दर्ज पाया गया, मसाहती खसरा 1988-89 में कुल खसरा 444 कुल रकबा 223.42 एकड़ भूमि दर्ज होना पाया गया, मसाहती खसरा 2008-09 के अनुसार कुल खसरा 760 कुल रकबा 354.31 एकड़ भूमि होना दर्ज पाया गया, आनलाईन भूईयां वर्ष 2023 में कुल खसरा 823 कुल रकबा 148.892 हे. / 367. 920 एकड़ क्षेत्रफल दर्शित है।


उपरोक्त संबंध में आदेशानुसार गठित संयुक्त जांच दल द्वारा प्राप्त प्रतिवेदन अभिलेख के आधार पर एवं ग्रामवासियों के उपस्थिति में उपलब्ध चालू नक्शा में अंकित चान्दा-मुनारा का मौका मिलान किया गया तथा ग्राम सीमा का जीपीएस लोकेशन लिया गया। उपलब्ध चालू नक्शा में दर्शित सीमा के अनुसार ग्राम का कुल भौगोलिक क्षेत्र का रकबा लगभग 215.106 हे. / 531.52 एकड़ मिलता है तथा ग्रामवासियों के सिवाना (सीमा) के बताये अनुसार मौका मिलान किया गया जिसका कुल भौगोलिक रकबा भी उपलब्ध चालू नक्शे के रकबे के अनुसार पाया गया, परन्तु राजस्व अभिलेख खसरा पांचसाला, खतौनी बी-1 में उपलब्ध नहीं है, इस प्रकार ग्राम जटराज (मसाहती ग्राम चन्द्रनगर) का उपलब्ध चालू नक्शा एवं ग्राम सीमा का मौका मिलान से कुल भौगोलिक क्षेत्रफल लगभग 215.106 हे. / 531.52 एकड़ मिलता है।
