



- 3) To sign and submit all necessary forms, returns, applications or other deeds and documents before aforesaid authorities and to comply with the provisions of various statutory laws applicable to the said GA, for and on behalf of the Company.
- 4) To obtain registration as required under provisions of various legislations pertaining to Goods & Service Tax, Value Added Tax, Central Excise, Customs and other applicable legislations.
