In exercise of powers vested in me vide letter No. PLG-C(1)-2/96 dated 17-01-1997 read with finance department letter No. Fin.-C(1)-1/83 dated 6<sup>th</sup> September, 1995 (SOE) (37) and further clarified vide letter No. Yojna (BASP)-1/67/97-98-1000 dated 28<sup>th</sup> February, 1997, the Administrative Approval of ₹ 11,61,89,000/- (Rupees Eleven Crores Sixty One Lakh Eighty Nine Thousand) only and Expenditure Sanction of ₹ 2,20,10,969/- (Rupees Two Crore Twenty Lakh Ten Thousand nine Hundred Sixty Nine) only is hereby accorded for the execution of following Schemes:-

1. The A/A is subject to the Technical Approval from competent authority and Executing agency will ensure that technical approval obtained well before initiating the work as per the Policy/Rule of the Govt.
2. The Executing Agency will not procure material in excess of the quantity required.
3. The work(s) will be executed after completing all codal formalities as per guidelines/Rules of the Govt.
4. The Expenditure in the current financial year 2018-19 will be restricted to the budget available and no excess expenditure will be allowed as per the rules.
5. The UCs/CCs of the sanctioned work(s) should invariably be sent to the D.C. as per the time schedule fixed for the completion of the work.
6. The work(s) will not create any new liability on the Govt., which is not provided in the sanction and does not authorize purchase of material, which is disallowed by the Govt. or not covered in the SOE mentioned below.
7. The sanction not entitle the executing agency to engage any additional staff, labour or manpower unless approval or allowed by the Govt. as per the rules.
8. The expenditure involved will be debitable to Major Head 5054-COL on Road & Bridges-04 District & Other Roads -800 Other Expenditure Backward Area Roads -37 Major works under Demand No. 15 for the year 2018-19 under BASP.
9. Before initiating the construction work (s) on Forest Land necessary approval under Forest Conservation Act, 1980 from Forest Department, if necessary.
10. The material should be purchased strictly complying with all the Govt. instructions issued from time to time under Himachal Pradesh Rules and Hon'ble Court Orders, if any.
11. As per the Guidelines of the Govt. already circulated the work(s) sanctioned should be completed within a space of three years in the budget allocated/available for a work (s) and the estimates of RNS (Really New Schemes) should be prepared accordingly under "Area Sub-Plan", if a work(s) could not be completed within a space of three years under "Backward Area Sub-Plan", it must be the responsibility of the concerned department to complete it from their own departmental funds as well as the priority of budget allocation should be given to the works which are being executed more than one year and nearly completion.
