Administrative Approval is hereby accorded for Construction of link road from Purmandal to Rajoli at an estimated cost of Rs.242.38 lacs (Rupees Two Crores forty two lacs and thirty eight thousand only) as per the details and cost abstract respectively to this order as per Annexure- I.

The Administrative Approval is however, subject to the following conditions:-

1. The scheme is approved under NABARD RIDF-XXV.
2. The works has been taken up for execution only after specific authorization of funds by the competent Authority.
3. The works has been executed after observing all Codal formalities / procedures.
4. It must be ensured that there shall be no multi-source of funding or overlapping of schemes under different programmes.
5. The scheme has been executed only after encumbrance's free land is available.
6. That the works are executed strictly as per provisions and specifications of the sanctioned estimates.
7. Schemes / project shall be completed within stipulated time.
8. There is no time over-run or cost over-run involved in the project.
9. Accord of Administrative Approval shall not be treated as an authority to spend money not provided for in the budget.
10. Quality control is mentioned in accordance with standards set under MORTH/IRC code.
11. The detailed estimate of the work shall be technically sanctioned by the competent authority and proposals strictly devised and designed as per the relevant code of MORD /MORTH and IRC Manual / specifications as per the relevant code.
12. Any such item(s) not covered under relevant schedule of rates is paid in accordance with the set codal procedure.
13. The structural design of the cross drainage has been got authenticated by the competent authority well before the execution of work. The design shall also account for the latest HFL.
14. The NOC from the concerned regulatory Authorities such as forest department etc. has been obtained before the commencement of the work.

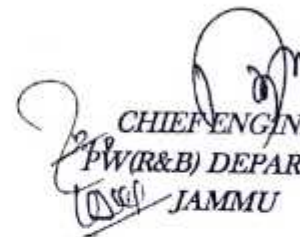
Subject: - Construction of link road from Purmandal to Rajoli (under NABARD XXV).
