Subject: Utilization and allocation of handed over land parcel of 126.018 Ha at Village Nhave, Tal. Uran, Raigad district as Compensatory afforestation land for various projects of CIDCO.

Respected Sir,

It is to inform that CIDCO has already handed over a non-forest land parcel as CA land of 126.018 Ha at Village Nhave, Tal. Uran in Survey No.57, 60 to 61, Part 75, 76 to 135, 142 to 161, 164, 165 to the forest department in lieu of project of Rajivali-Sativali Vasai-Virar Water Supply Project which later got cancelled rendering the provided CA land un-utilized. On request of CIDCO vide Letter D.O.No. CIDCO/MD/379 dt. 22.07.2022 (**Refer Annexure-I**) of adjusting this land parcel of 126.018 Ha for other ongoing/proposed Projects, the State Government had accepted the same and granted its concurrence vide Letter No. FLD-2021/ P.N. 136/F-10 dtd. 14.12.2022 (**Refer Annexure-II**).

In line of above, CIDCO had partially utilized the above CA land for some of the projects; whereas for other ongoing/proposed projects, CIDCO intends to utilize the balance land parcel. Accordingly, a revised list of Projects in supersession of those included in Annexure-I, wherein the above land parcel is either utilized or proposed to be utilize as CA land is tabulated as under:

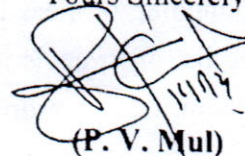
