सिंगरौली जिले में “जल जीवन मिशन” अंतर्गत गोंड देवसर समूह जल प्रदाय योजना का निर्माण किया जाना प्रस्तावित है। उक्त परियोजना से वन मंडल सिंगरौली के परिक्षेत्र बरगवां के वनखण्ड के कक्ष क्रमांक PF 745, PF 746, PF 747, PF 748, PF 749 PF 750, PF 751, PF 752, PF 755 , PF 763, PF 832 , एवं PF 833 परिक्षेत्र जियावन के वनखण्ड में कुल क्षेत्रफल 4.8959 हेक्टेयर वन भूमि प्रभावित होगी।

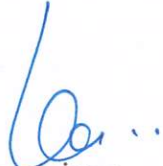

प्रमाणित किया जाता है कि जल जीवन मिशन अंतर्गत सिंगरौली जिले के ग्रामीण क्षेत्रों के लिए गोंण्ड देवसर समूह जल प्रदाय योजना का क्रियान्वयन किया जाना है। इस मिशन के अंतर्गत ग्रामीण क्षेत्रों के हर घर तक पानी पहुँचाना निर्धारित किया गया है। जिसके अंतर्गत ग्रामीण क्षेत्रों में उच्चस्तरीय टंकी का निर्माण होना है। उन टंकियों को भरने के लिए एक गांव से दूसरे गांव तक पानी की पाइप लाइन विछाने का कार्य किया जाना है। जिसमें वन मंडल सिंगरौली के कुछ परिक्षेत्रों की भूमि प्रभावित हो रही है।

गांव में उन घरों तक पानी पहुंचाने का अन्य कोई वैकल्पिक मार्ग नहीं है। और यह मार्ग सड़क के समानांतर होने के कारण इसमें वन की न्यूनतम भूमि प्रभावित हो रही है। और यह मार्ग तकनीकी और वित्तीय दृष्टि से उपयुक्त है।

6. The provision of drinking water and toilet facilities at all fuel stations should be according to the approved drawings and specifications and to the full satisfaction of the Highway Administration. The drinking water and toilet facilities shall be accessible to the public, round the clock. In order to inform the public about these, a retro reflective display board showing availability of such facilities shall be installed before the entry to the fuel Stations.
7. Slab Culverts with gratings to be provided in the line of storm water drain on entry and exit approaches to cater to the expected discharge. The working drawing with hydraulic design shall be submitted to Divisional Manager, MPRDC for approval prior to the construction.
8. It has to be ensured that there shall be adequate drainage system on the access to the fuel station and inside its area so that surface water does not flow over the highway and no water logging takes place. The Oil Company/Owner may construct the Fuel Station along with its access as per approved drawings at their own cost within 6 months of the issue of this Provisional NOC. After the construction as per approved drawings and to the satisfaction of the Highway Authority, the final approval may be given within 30 days of the receipt of communication along with the "As Built Drawing" from the applicant about the completion of construction work. License deed may be signed by the Divisional Manager, MPRDC. In case, the construction is not done in one year, the provisional approval shall be deemed to be cancelled, unless renewed by the Highway Authority.

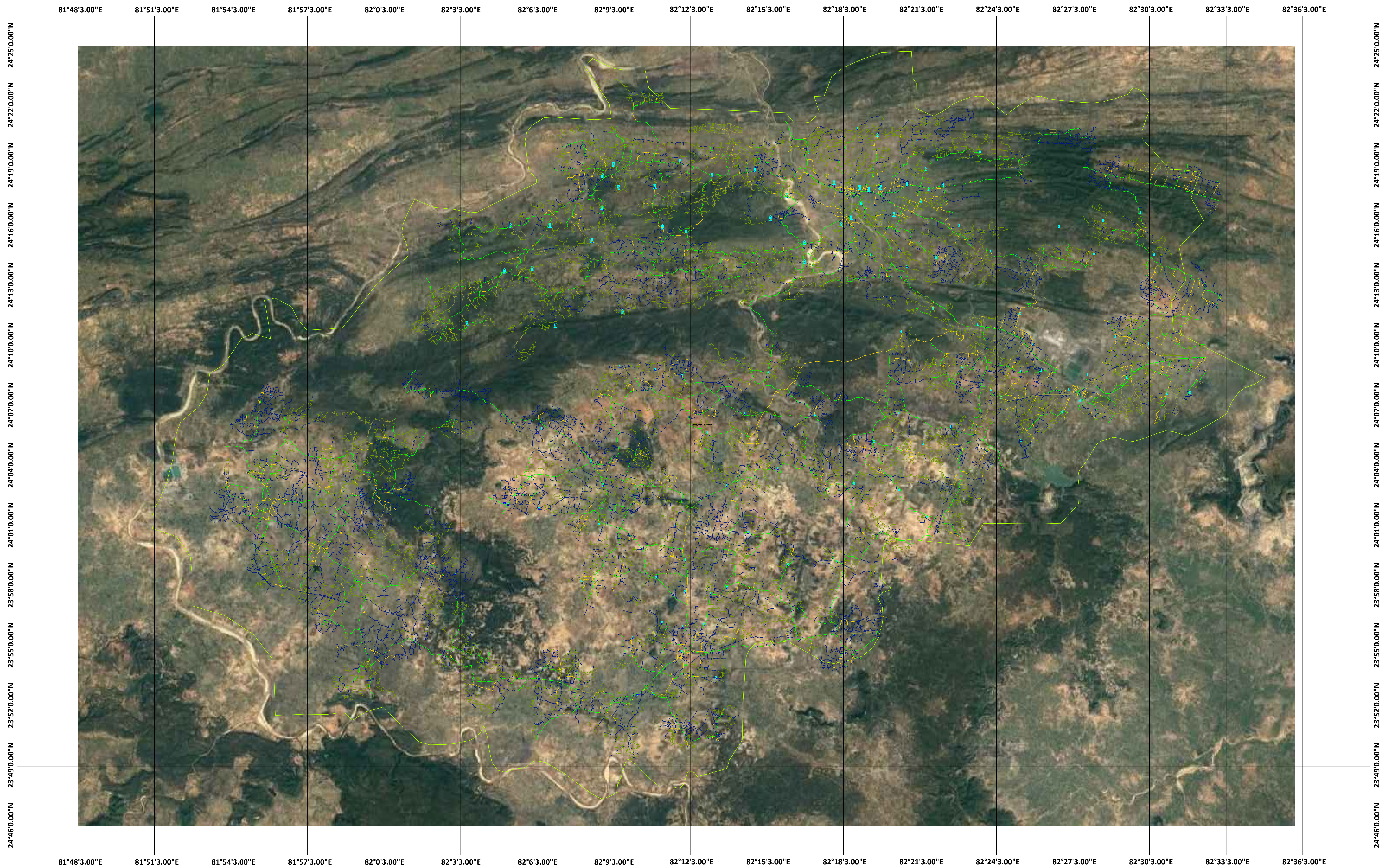

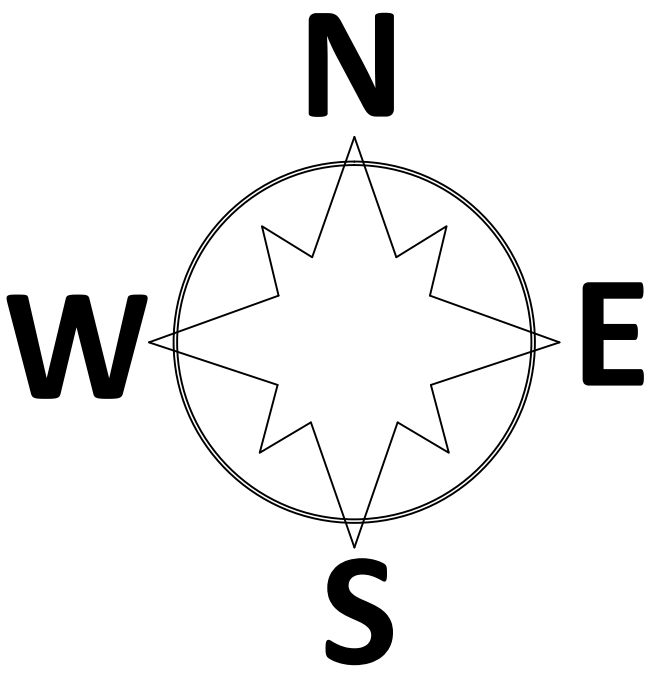

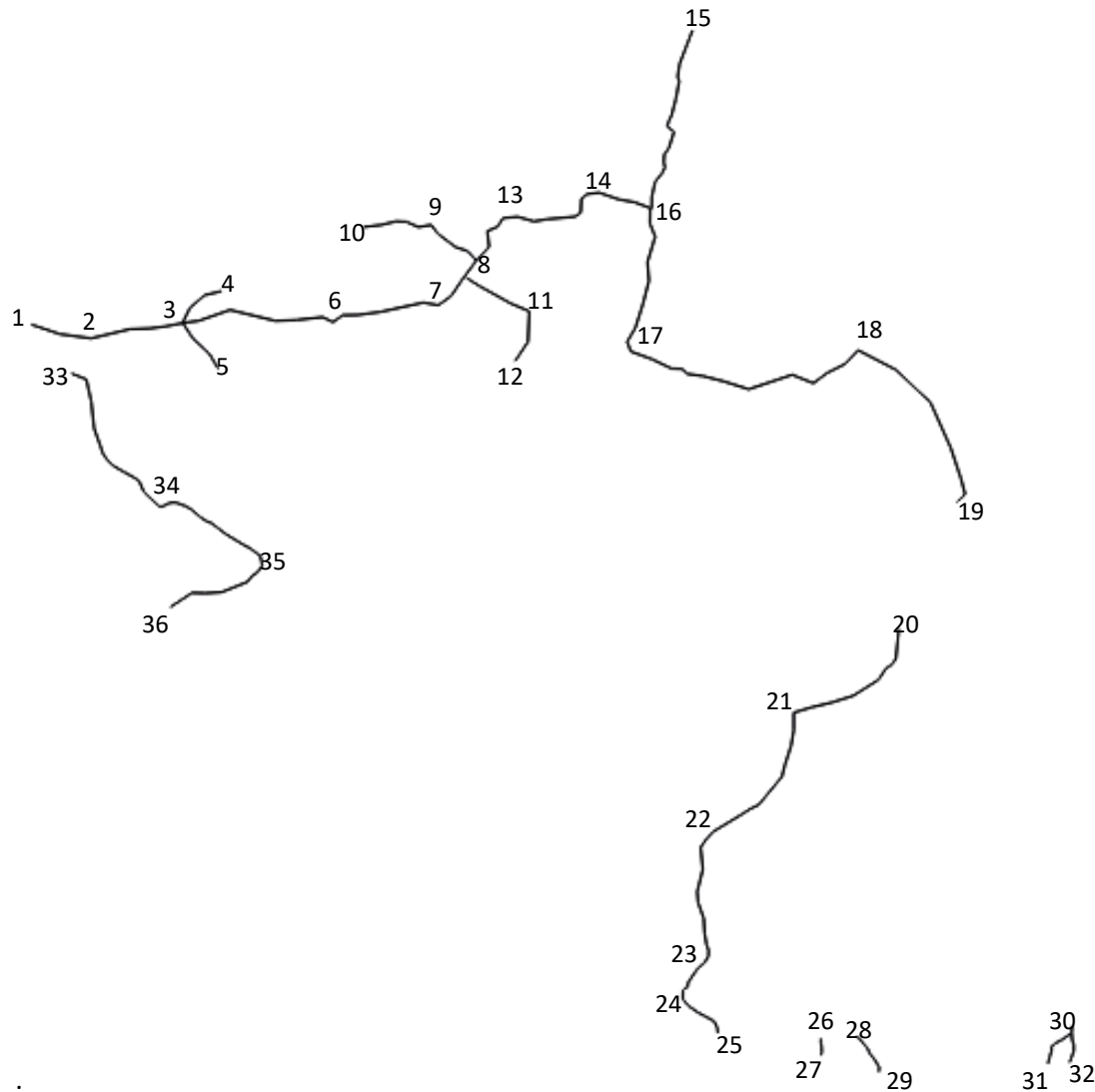
GOND DEVSAR MULTI VILLAGE RURAL WATER SUPPLY SCHEME
