Diversion of 1.9337 ha, of forest land in Saidulanama RF of Nalgonda Division for Rallway siding taking off from Vishnupuram — Janpahad Main BG Line to bring raw materials to the Plant and for movement of finished goods to out station destinations in favour of Deccan Cements Ltd.

Sir.

Kindly refer to State Government's letter No.4279/FOR.I(1)/2009-1 dated 16.07.2009 and 06.05.2010 seeking prior approval of the Central Government in accordance with Section'2' of the Forest (Conservation) Act, 1980 for the above project. The proposal was accorded in-principle (Stage-I) approval by the Central Government vide letter of even number dated 21st May, 2010. The State Government vide letter No.4279/FOR.I(1)/2009 dated 25.06.2011 have reported compilance to the conditions stipulated in the in-principle approval.

After careful consideration of the proposal of State Government, I am directed to convey Central Government's approval (Stage-II) under Section'2' of Forest (Conservation) Act, 1980 for diversion of 1,9337 ha, of forest land in Saidulanama RF of Nalgorida Division for construction of Railway siding in stretch-II to bring raw materials to the Plant and for movement of finished goods to out station destinations in favour of Deccan Cements Ltd, for a period of 20 years, subject to the following conditions:-

- 1. The legal status of the forest land shall remain unchanged.
- The demarcation of the forest area proposed for diversion shall be carried out by erecting cement concrete pillars duly numbered at an interval of 20 meters at the cost of user agency.
- 3. The compensatory afforestation shall be raised over 1.9337 ha, of identified non-forest land in Sy.No.187/a,aa,e,ee,uv & 189/a of Pulicheria village of Pedavoora Mandal, at the cost of user agency. The State Government shall obtain prior permission of Central Government for change of location and schedule of compensatory afforestation site, if any.
- 4. The non-forest land for compensatory afforestation shall be notified by the State Government as PF/RF under Indian Forest Act, 1927 or the State Forest Act and Nodal Officer (FCA) shall report the compliance within six months.

- 5. The additional amount of the Net Present Value (NPV) of the diverted forest land if any becoming due after revision of the same by the Hon'ble Supreme Court of India in future, shall be charged by the State Government from the user agency and deposited either in SB A/c No.SB01025198- CAF Andhra Pradesh, Corporation Bank, CGQ Complex, Lodhi Road, New Delhi-110003 (RTGS/IFSC No.CORP0000371) or in SB A/c No.344902010105 407- ANDHRA PRADESH CAMPA, Union Bank of India, Sundar Nagar, New Delhi-110003 (RTGS/IFSC No.UBIN0534498).
- 6. The total forest area utilized for the project shall not exceed 1.9337 ha. In case the land is not taken over by the user agency or the same is not used for the stipulated purpose within a period of two years, then the area in question shall be taken back by the Forest Department.
