

The authorization/release of funds is subject to following conditions:-

1. All codal formalities shall be adhered to before executing the project;
2. The project shall be executed as per the approved components sanctioned by the Ministry and prescribed guidelines of the scheme.
3. The land for the project shall be made available free of cost. No portion of the sanctioned project shall be executed/implemented on land/property owned by the private individual or trust.
4. The implementing agency shall submit the physical and financial progress to this on monthly basis.
5. The executing agency shall put in place the mandatory facilities for barrier free access by physically disabled persons.
6. The project shall be completed and commissioned within 36 months without any cost escalation;
7. The implementing agency shall follow PWD Schedule of Rates. All necessary clearances which are required as per the prevailing rules and regulation shall be obtained before undertaking the project.
8. There shall be no overlapping of funds for the project being executed.
9. No diversion of funds is allowed without the prior approval of the Competent Authority
10. The Implementing agency shall be responsible for quality control/Reasonability of Rates.

Managing Director, J&K State Cable Car Corp is hereby directed to transfer an amount of Rs. 97.18 lacs in favour of CEO, Kokernag Dev. Authority for the purpose through Bank Draft/Cheque out of Bank Account No. 0005040100011580 under intimation to this Department.
