(i)	Short narrative of the proposed and project/scheme for which the forest land is required.	<p>Slum Development Project –</p> <p>Sanjaynagar is one of Slums notified by Municipal Council Gondia , Planning Authority for Gondia City vide its notification No.MCG/Slum-58-133.2000 dt.25.12.2000. It covers near about .6.53 ha Zudapi Jungle &amp; Grass land from Kh.No.385/1K/1,385/2 &amp; 385/4 of Village-Gondia Khurd,Tahsil Gondia,Distt.Gondia. As per survey done by TILR (Taluka Inspector of Revenue Records) Gondia,there are 662 encroachers (slum Dwellers) on the Zudapi Jungle &amp; Grass land as well as non forest land. This notified slum is developing in haphazard manner.It is impossible to provide civic amenities i.e. proper roads,water supply, drains &amp; electricity in proper manner without rearranging the encroached pieces of land. i.e. unauthorised plots.Therefore Municipal Council, Gondia has decided to regulise &amp; develop the the slum. The main aim of the project is to provide properly plotted land to encroachers (slum dewellers) with least displacement of land under encroachment.The forest proposal is prepared for 6.53 has.Zudapi Jungle &amp; Grass land required for the regularisation of enchroachment at Sanjaynagar of village Gondia khurd Tahsil-Gondia District-Gondia.</p>

(iv)	Justification for locating the project in forest area.	Slum dwellers are residing on this encroached Zudapi Jungle & Grass land for the period more than last twenty years. It is impossible to evacuate the encroachers & made land available for either use. As per Development plan of Gondia City sanctioned by the Govt.of Maharashtra vide its notification no.TPS-2311/2186/CR-249(B)/201/UD-9 dt.4 <sup>th</sup> April 2012, Sanjaynagar slum comes under Residential Zone, 12mt. & 24mt. wide Development Plan Roads. & north eastern portion of slum is affected by site No.S/199 play Ground. There is no alternative land for rehabilitation of slum
