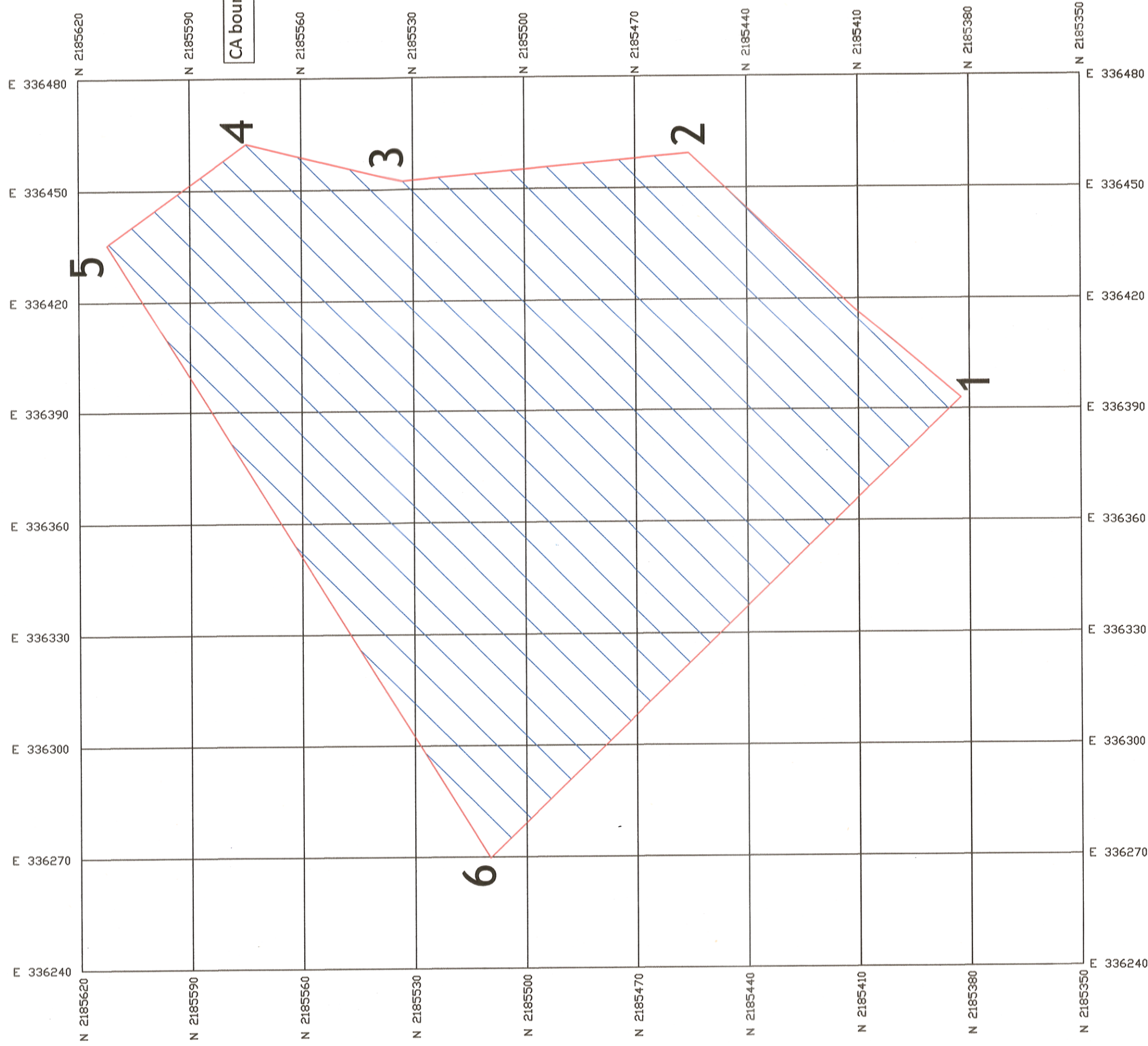


Geo-referenced DGPS GRID Map
