4	Administrative approval and geological report not found uploaded in additional documents in Part I. State Government may upload the administrative approval and geologist report as additional documents in Part I.	Administrative approval and geological report has been uploaded.
5	Aerial distance certificate of the proposed area for the national park/wildlife sanctuary is mentioned as 0.025 km but nothing is mentioned to this effect in para-8(iii) & 8(iv) of Part II. State Government is requested to submit the CWLW comments/Certificate in this regard and furnish the information against para 8(iii) & (iv) of Part II online.	Aerial distance certificate has been uploaded.
6	In para A-2 (I) of Part I name of User Agency is mentioned as PMGSY instead of Rural Development Department. State Government may fill the correct information of User Agency at Para A-2, Part I.	In this matter a letter from Nodal office vide letter No- 1405/1G, Date-27.11.2019 written to the change the User Agency.
7	Muck disposal area mentioned in para B-2.4 of Part I does not match with the area of muck disposal site mentioned in the muck disposal plan. State Government may submit clarification and remove this discrepancy.	Muck disposal has been uploaded.

8	It is seen from the CA scheme uploaded in additional documents (at Sr. No. 01) in Part I Siras, Kanchnar, Sahtoot and Bhimal are proposed to be planted in CA area in RF but these species do not appear to be local species in the RF area. Further the Cost of GA over 5.445 ha area has been worked out of Rs. 11,39,997.87 but the amount has been mentioned as Rs. 15,17,330,.93 as quoted in PCCF's letter date-21.11.2017, which is not understood. State Government may remove this discrepancy and provide the correct information in this regard.	CA scheme has been uploaded.
9	Land Schedule uploaded in Part I is different from the one uploaded in Part II and provided in hard copy. State Government may remove this discrepancy and submit the correct land schedule.	Corrected Land Schedule has been uploaded.
10	CA site Suitability Certificate uploaded in Part II and copy provided with the proposal is not appropriate. State Government may submit/upload the appropriate CA site suitability certificate.	Related to DFO.
11	In Para-14, Part II (District Profile) CA Stipulated is not commensurate with the forest land diverted and progress of CA is equal to CA stipulated. State Government may provide the correct data in the district profile at Para 14, Part II	Related to DFO.
