Sub: Regarding exemption from the purview of *Van (Sanrakshan Evam Samvardhan) Adhiniyam* 1980, as per the proviso given under clause (b) of Sub-section (1) of Section-1A of the Adhiniyam, r/w Consolidated Guidelines and Clarifications dtd.29.12.2023 issued by MOEF & CC, Govt. of India, with respect to 23.80 hect mining lease area of Kalarangiatta Chromite Mines of M/s Ferro Alloys Corporation Limited (FACOR).

## Dear Sir,

Inviting reference to your office letter bearing No. 69/5F (Forest Division) 107/2019, dtd. 03.01.2024 and in continuation to our previous various letters submitted to your good office on the subject cited above, we would like to appraise your goodness as under:

- 1. That the office of Tahasildar Sukinda vide its Letter No.2839 dtd.20.11.2014 and subsequently vide Letter No.2863 dtd.21.08.2023 has reported that the total 16 No. of plots (23.80 hect) mining lease area of Kalarangiatta Chromite Mines of FACOR were coming under forest category / jungle kisam (forest category) in the Sabik Settlement i.e prior to 25.10.1980. Copies of the said Tahasildar letters are enclosed herewith as Annexure-01 & 02 respectively.
- 2. That recently it is revealed from the Certified Copies of the Yadast Record as well as Amin Report collected from the office of Cuttack Major Land Settlement office that out of 16 Nos. plots of Kalarangiatta Chromite Mines, only 6 nos. of plots (Plot no. 215, 215/1663, 258,259,260 and 266) were coming under forest category and balance 10 Nos. plots (Plot no. 83,78,114,42,48,85,47,214,303 & 304) were coming under Non-Forest Category during Sabik Settlement i.e prior to 25.10.1980. The actual land status as per certified copy of the Yadast Record are appended below as **Schedule-A**:

The supporting evidence of the said Certified copies of the Yadast and Amin Report are enclosed herewith as **Annexure-03** Series for your kind perusal and references. According to the aforesaid **Schedule-A**, Ten number of Plots i.e. Plot No. 83,78,114, 42,48,85, 47, 214,303 & 304 (Total Area 4.305 Acre land) of Kalarangiatta Chromite Mining lease do not legally required Forest Clearance, as all the said plots were coming under Non-forest Category land prior to 1980 and now the status of the said plots are also remain unchanged i.e Non-forest category during Hal Settlement.

- 4. That since, all the Six number plots mentioned in Schedule-B of Kalarangiatta Mines were not declared as forest under the IFA-1927 under Clause-(i) of Para-1.1 of the Consolidated Guideline-2023 and the same has already been used for Non-forest purpose during Hal Settlement for which the Record of Rights (ROR) have been published on 01.04.1993 i.e prior to 12<sup>th</sup> December 1996 with approval of the competent authority as cited above. Hence the said 19.49 hect land is legally eligible to be exempted from the purview of the Adhiniyam as per the proviso given under clause (b) of sub-section (1) of newly inserted Section 1A of the Adhiniyam and in accordance with the Clause (ii) of Para-1.1 of the Consolidated Guidelines and Clarifications issued on 29<sup>th</sup> December 2023 by MOEF & CC, Government of India New Delhi.
- 5. That as far as the compliance to your office Letter No.69/5F (Forest Division) 107/2019, dtd. 03.01.2024 is concerned, please find herewith the compliance report required for **Section-A** of the said letter as per **Schedule-C** appended below:

- 6. That in compliance to the Section-B of the said letter dtd.03.01.2024, we would like to submit before your good office that Department of Steel and Mines, Government of Odisha vide its Proceeding No.6177/SM dtd.17.07.2007 has granted mining lease over 23.80 hect of Non-Forest Land to FACOR. Subsequently the Mining Lease has been executed on 18.04.2008, between the State Government represented by the Collector of Jajpur and the Ferro Alloys Corporation Ltd. Since we got the legal right for mining over the said 23.80 hect mining lease of Kalarangiatta Chromite Mines, the question of Year wise mining plan, Land Schedule, Satellite Map, Land use Plan and Actual extraction status as on 2004 does not arise.
- 7. That vide our previous letter bearing No. FACOR /Bhadrak /Legal /106 /2023, Dated 18.12.2023, we have already submitted before your good office that all the 16 nos. of mining lease plots of Kalarangiatta Mines are not coming under DLC Report of Kalarangiatta Mouza of Jajpur District.

## **PRAYER**

In light of the aforesaid facts, land records of Government of Odisha as well as documents of IBM and Mining Department we do hereby request your good office kindly to :

- (1) Allow mining operation in the 10 nos. of Non-forest plots cited above in the **Schedule- A** as the Forest Conservation Act and Rules are not applicable for the said Plots.
- (2) Issue necessary order for exemption of 6 nos. of Forest plots (as per Schedule-B) which have been changed to Non-Forest category and been used for Non-forest purpose during Hal Settlement for which the Record of Rights (ROR) have been published on 01.04.1993 i.e prior to 12<sup>th</sup> December 1996 with approval of the competent authority of State Government of Odisha. As such the said 6 nos. of plots are liable to be exempted from the purview of Van (Sanrakshan Evam Samvardhan) Adhiniyam 1980, as per the proviso given under clause (b) of Sub-section of Section-1A of the Adhiniyam, r/w Consolidated Guidelines and Clarifications dtd.29.12.2023 issued by MOEF & CC, Govt. of India.
- (3) Allow us to withdraw the Forest Diversion Proposal filed earlier in the Parivesh Portal vide Proposal No. FP/OR/MIN/16453/2015 as the mining lease area is not coming under the definition of "Forest" as per the proviso of Forest Conservation Act-2023 effective from 1<sup>st</sup> Day of December 2023.
- (4) And arrange to intimate the office of Deputy Director of Mines Jajpur Road to resume the mining operation of Kalarangiatta Chromite Mines of M/s. Ferro Alloys Corporation Ltd. without Forest Clearance.





Your kind co-operation and necessary favorable order in this regard will help in facilitating the basic economic needs of more than 25,000 poor families who are directly and indirectly dependents upon this mine and our Ferro Chrome Plant located at Randia Bhadrak (since this is a Captive Mine for our Plant). Further this will also help in generating Crores of Revenues / Royalty for the State Government of Odisha.
