The erection of 230 KV DC line on DC towers from Cuddalore (via Neyveli ) to Veerapuram (S.P.Koil) is under progress. In this regard we would like to mention the importance of this scheme to General Public as described below,

1. The Tamil nadu Transmission Corporation has approved the proposal for 230 KV DC line on DC towers from Cuddalore (via Neyveli ) to Veerapuram (S.P.Koil) at an approximate cost of Rs. 1.42 Crores vide reference (1) above cited to transmit the power generated from Neyveli Thermal Power Station to Kanchipuram district.
2. The above said scheme was vide published in Tamil Nadu Government Gazette on 23.03.2016 and local news papers (Indian Express & Dhinamani) on 10.01.2016 under the Electricity ACT 2003 and it is informed that by virtue of the provisions contained in sub section (2) (a) of section 185 of the Electricity Act, 2003, the Board being the Transmission utility and Licensee will exercise the powers of the Telegraph Authority under the provisions of section 164 of the Electricity Act, 2003 which have already been conferred upon the Board under section 51 of the Indian Electricity Act, 1910.
3. Hence the erection of this transmission line is very essential to maintain uninterrupted power supply to the Kanchipuram district and the Government of Tamilnadu is closely monitoring the progress of the work. The work of foundation

for towers in the above line for the remaining portion (Except the Reserve forest lands in Chettipunniyam and Thirutheri of Chengalpattu range) is under progress.

4. The above proposed EHT line transmission scheme can be carried out in the originally approved route. The importance of this transmission scheme is in order to transmit the power generated from the Neyveli Thermal Power Station to cater the growing demand in Kanchipuram district.
5. There is no alternate Government /Vacant land to lay EHT towers in the above said areas since the adjacent portions were covered with Residential buildings, Habitations etc., and hence it is proposed to carry over the EHT line through the said reserve forests.
6. Necessary permission has been obtained to conduct survey in the from the Principle Chief Conservator of forests, Chennai vide reference cited (2) above cited.
7. "Forest Right Certificate" issued by the District Collector, Kanchipuram has to be uploaded through the online portal to obtain forest clearance in the enclosed formats as per the guidelines issued by the Ministry of Environment and Forests/ Government of India vide reference (3) above cited. (copy enclosed )
8. Hence, it is requested that certificate may kindly be issued that there is no alternate Government/Vacant lands available for the erection of above EHT line and the line can be carryover only through Chiettypunniyam and Thirutheri Reserve Forests of Chengalpattu Range please.

Under the circumstances reported by the Conservator of Forests, Chennai, District Forest Officers, Chengalpattu Division, Kancheepuram is permitted to accord necessary permission under section 21 of Tamil Nadu Forest Act, 1882 to the Executive Engineer/Civil, Transmission Projects/General Construction Circle-II, TANTRANSCO/Guindy, Chennai 32 to enter upon the forest land to conduct check survey using GPS and total station in Thirutheri Reserved Forests for supply, erection, testing and commissioning of 230 KV transmission lines in various regions of the state along with 230 KV bays under Turnkey contract for Cuddalore to Singaperumal Koil (Veerapuram) via Neyveli 230 KV DC line on DC towers (line-F) Location No. AP 60 to AP 67 – Passes through Thirutheri RF

of Chengalpattu Forest Division without any cutting of trees and without damage of flora / fauna and as per Forest (Conservation) Act, 1980 guidelines under para 1.3 (i) investigation and survey with usual terms and conditions in force.

2) He is requested to ensure that

- i) No trees should be cut and removed.
- ii) No damage should be caused to the Forests, Wildlife and Environment.
- iii) No road should be formed for transportation of machinery.
- iv) No labour camp should be erected within Reserved Forest.
- v) Fire near by Forest should be avoided.
- vi) No cooking is allowed within the Reserved Forest
- vii) The work should be carried out between 8.00 A.M. to 6.00 P.M.
- viii) The District Forest Officer may also add suitable conditions if any.
- ix) Report on the completion of the conditions stipulated should be submitted

x) If any violation is noticed in this work, the District Forest Officer may report to this office at once and action should be taken as per existing rules by District Forest Officer / Conservator of Forests.
