

Non Forest Land is proposed for diversion for entry/exit to HPCL Retail Outlet on Pilibhit-Madhotanda Road, In KM No. 2.00 (CH. 1.396 to 1.439) at Gata No 288, Vill Chdaiyadah , Tehsil & Distt Pilibhit (Uttar Pradesh)

**Mitigation measures and conditions are suggested as under**

1. Protection and mitigation measures for wildlife should be ensured as per standard practice in such cases.
2. Land shall not be used for any other purpose than that specified in the proposal.
3. Rules and regulation of the concerned department for establishing the project shall be compiled with
4. The instructions/orders pass by the State/Govt./Central Govt. and the direction passed by Hon'ble High Court/Supreme Court from time regarding such project shall be compiled with.
5. User agency will ensure that the personnel engaged in the project shall observe the provision of the Wilflife (Protection) Act, 1972 & Rules made thereafter.
6. Construction waste materials will not be thrown inside the sanctuary area or the movement corridor of wildlife.
7. User agency will take all precaution including technical measures to contain the noise and air pollution, protection from fire due to construction activities.
8. The project proponent shall obtain consent to establish and to operate form U.P. Pollution Control Borad and effectively implement all the conditions stipulated therein.
9. The project proponent shall undertake plantation/forestaion work by plantion the native species in the nearly adjacent area/sanctuary for which necessary finance will be provided by the user agency.
10. As per letter F.No. 5-2007-FC, Ministry of Environment & Forest (F.C. Division) Government of India, New Delhi, Dated 08.02.2009 and the GO of Uttar Pradesh Shashan (Van Anubhag-2) letter no. Writ 526/14-2-2008 dated 22.08.2008, the use of the non forest land area of 0.16403 Ha. withing Protected Area Boundary of Pilibhit Tiger Reserve may be permitted on payment of and amount equivalent to the NPV payable for the adjoining forest & Non Forest Land (Govt. Land) of 0.16403 Ha. one time of the present value payable as per the GOI guidelines.
11. No labor camp shall be establised in the sanctuary/forest area or other sensitive area
12. Two GPS sets shall be provided to the Meert forest division for the survey and demarcation of the sanctuary boundries.
13. The user agency shall extend all support to forest department in case of any forest & wildlife offence.
