Approval of the Commissioner, NESTS is hereby conveyed to sanction the new EMRSs with immediate effect at the following locations: -



A copy of the map of the land along with survey number and handing over/taking over letter may be submitted to NESTS. The MLP shall be planned considering the type and shape of the available land and the building features of EMRS may be avoided in the low-lying area to avoid additional cost. It may also be ensured that the demarcated land area shall be as per area approved in the sanction memo.
