It is to inform you that the land donated by Lengpui Village Council/Court for establishment of the premier National Institute of Technology, Mizoram is within Tlawing Riverine Reserve Forest and Gomari Plantation have been raised by the Department during 1999 & 2000 under Social Forestry Scheme. On inspection of the site, it is found that there are 3070 Nos. of Gomari trees having cubical content of 403,806 cum to be removed from the proposed project site.

Though the Department also warmly welcomes establishment of the NIT in the State, there are mandatory guidelines to be followed in case of non-forest activities on forest lands.

The NIT authorities/Education Department (Higher & Technical Education) is therefore, requested to seek prior approval of the Central Government under section 2 of the Forest (Conservation) Act,1980 for diversion of forest land in consultation with DFO Mamit or try to find suitable non-forest lands for establishment of the premier institute.



It is also observed that you have felled and disposed off 3070 numbers of value trees without obtaining any approval from competent authority. Keeping in view of the above facts, you are requested to totally stop further encroachment and illegal activities.

- (ii) During 2017, the DFO, Mamit Division and the Addl. PCCF, Environment Forest & Climate Change Department, Mizoram informed the NIT Mizoram of the 'illegal encroachment' and the felling of 3070 trees within the permanent campus area, copy at Annexure-II.

 NIT Mizoram received a 'Stay Order Notice' from the DFO Mamit Division and to stop all forms of encroachment on the forest land, copy at Annexure-III.
- (iii) During 2018, the Project Management Consultants, i.e. M/s IRCON International Limited informed the NIT Mizoram that Rs. 188.07 Lakhs approximately, being the cost of afforestation of 150.46 Ha is being levied as Penal Compensatory Afforestation; for violation of Forest Clearance and due to the continued encroachment and illicit construction, copy at Annexure-IV.

Till date, the Penal Compensatory Afforestation costs have not been paid nor Forest Clearance obtained.

(iv) The referred Land Lease Certificate of 2015 has been leased to the Secretary to the Govt. of Mizoram, Higher & Technical Education Department, Aizawl, copy at Annexure-V.

Given the afore stated, I would like to request you to kindly revisit the issues regarding the land acquisition/lease of NIT Mizoram as:

- (i) The scenario and reason by which the NIT Mizoram was provided land within the statutory confines of a notified riverine forest reserve, a land mass which was not a free holding one and not free of encumbrances.
- (ii) The transfer of land/ Land Lease Certificate may be issued to the Director, NIT Mizoram and that the current Land Lease Certificate issued in the name of Secretary to the Govt. of Mizoram, Higher & Technical Education Department, Aizawl may be changed.

The standard 'Terms & Conditions of Lease' of the Land Revenue and Settlement Department, Govt. of Mizoram may also be entered and signed afresh between the concerned Department and NIT Mizoram.

(iii) The issuance of the Stay Order Notice and payment of Penal Cost Afforestation may be reviewed and the matter be adjudicated by the State Government with the concerned Department and preferably taken up at the Central level, if called for; as the ground issues are pertinent to the State Government.

STAY ORDER NOTICE

This is to state that <u>half a mile (804 meters approximately)</u> on either side of *Tlawng (Duleswari) river* had been constituted as *Riverine Reserved Forest* (RRF) in exercise of power delegated under *Section 14 of Mizoram* (Forest) Act, 1955 by the then Mizo District Council issued vide Assam Gazette 19th May, 1965.

This is also to state (that location of on-going works of NIT campus, Lengpui is situated inside Tlawng Riverine Reserved Forest. And till today, the location and area in which NIT campus is being established is still inside riverine reserve forest as there is no de-reservation of the said forest land. Construction and establishment of non-forestry structures inside the reserved forest without obtaining permission is an Encroachment on forest land.)

This is also to state that *Deputy Registrar, NIT*, Aizawl had also been informed to apply and approach Environment, Forests & Climate Change Department to obtain permission for construction. Deputy Registrar, NIT, Aizawl had also been supplied with prescribed Forms for seeking forest clearance vide this office letter *No.B.11011/2/01-FDM/2240-43 dt. 27.10.2016*.

This is also to state that Assessment of the Encroachment Area and counting of the number of trees had also been carried out by the concerned Range Forest Officer, (Lengpui RFO) and his report had been furnished *vide No.B.13013/2/2006-LFR/1019 dt.13.1.2017* in which it is shown that 3070 Nos of trees of forest department plantation were available within the encroached area by NIT, Aizawl and it appears several trees have been felled without obtaining permission.

This is also to state that, Deputy Registrar, NIT had been reminded to initiate for regularization of the above encroachment on forest land vide No.B.11011/2/2001-FDM/815-818 dt. 9.8.2017 and it had been clearly informed that permission in the form of Forest Clearance is required.

This is also to state that, till today, this office has not received application from NIT, Aizawl for regularization and utilization of the forest land for non-forestry purpose with payment of NPV for mutation. Now, it is evident that the encroacher is not paying attention to the repeated intimation from the office of the undersigned and there is enough reason to presume that the encroacher is not intending to apply and pursue the matter as per the



prescribed guidelines issued by the *Ministry of Environment, Forest and Climate Change (MoEF&CC)*.

This is also to state that, Forest (Conservation) Act, 1980 (Under Section 2) has clearly envisages that no part of reserve forest should be encroached for non-forestry purposes without permission from Competent Authority.

Therefore, keeping in view of the above facts and under these circumstances, in order to protect the reserve forests and belonging to the government and most importantly, in the Interest of the Public; now, this Stay Order is issued that encroachment should be stopped by the user agency. Director, NIT, Aizawl is hereby informed to stop all forms of encroachment on forest land. He is further informed to refrain from further felling of trees and executing of other illicit activities within the said forest land.
