

- 7 These should be laid strictly as per drawing by adopting confined cut excavation method of the road land, the refilling of the trenches shall be as per MORT&H specifications.
- 8 If the department considers it necessary in future to move/remove the water supply pipe line for any work of improvement or repair of road, it will be carried

out at the cost of your department.


9. Your department shall take prior approval from this department before undertaking any work of installation, shifting of the trenches or alternations to the Water supply pipeline.
