Sir,

This is in reference to the subject project vide which the Forest Proposal No. FP/UK/ROAD/146663/2021 dated 01.09.2021 has been uploaded on on Parivesh portal on 16.04.2022.

2. In reference to your office letter cited above, it is to inform that during the enumeration of forest trees, slight changes in forest boundaries were observed, resulting in change of area of forest land. Earlier, the proposal was submitted with forest area as 19.8576 Ha, but now the area is revised as 19.8345 Ha.

3. Due to the above change, the relevant documents have been modified and a copy of the same is enclosed herewith. The revised documents have also been uploaded on Parivesh portal. The dispensation of Compensatory Afforestation over double the degraded forest land i.e. 39.6690 Ha will now be required.

In addition to above, to meet the prerequisite for forest clearance, CA land coordinates are also required to prepare map and uploading on Parivesh Portal. Therefore, it is requested to provide the same at the earliest.
