In compliance of the Ministry of Environment and Forests (MoEF), Government of India's letter No.11-9/98-FC (pt) dated 3rd August 2009 wherein the MOEF issued guidelines on submission of evidences for having initiated and completed the process of settlement of rights under the scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006 ('FRA', for short) on the forest land proposed to be diverted for non-forest purposes read with MoEF's letter dated 5th February 2013 where in MoEF issued certain relaxation in respect of linear projects, it is certified that 2.325 hectares of forest land proposed to be diverted in favour of Superintending Engineer TDWSP (RWS&S) Circle Karimnagar, for Laying of pipeline and construction of structures in Segment 15/3 (Mahamutharam) lying in Shatrajpalli & Rudraram Habitations of Malhar Rao Mandal, Marripalli & Baswapur Habitations of Kataram Mandal and Polaram, Jeelapalli, Parlapalli, Pegadapalli, Nimmagudem, Keshavapur, Narsingapur, Erraram, Borlagudem & Pochampally Habitations of Mahamutharam Mandal of Jayashankar District falls within jurisdiction of Mahadevpur, Bhupalpally, Azamnagar and Chinthakani Ranges of Mahadevpur Forest Division.

It is further certified that:

- (a) The complete process for identification and settlement of rights under the FRA has been carried out for the entire 2.325 hectares of forest area proposed for diversion. A copy of records of all consultations and meetings of the Forest Rights Committee(s), Gram Sabha(s) and Sub-Divisional Level Committee are enclosed as annexure-1 to annexure-31;
- (b) The diversion of forest land for facilities managed by the Government as required under section 3 (2) of the FRA have been completed and the Gramasabhas have given their consent to it;
- (c) The proposal does not involve recognised rights of Primitive Tribal Groups and Preagricultural Communities.
