





For the execution of the above work, felling of trees of any nature (Planted / Spontaneous growth) will not be done and alignment will be carried out to avoid removal of trees in the alignment path. Hence Net Present Value is not payable in the present case.

However, if subsequently any clarification / order is issued by the Central Government / Hon'ble Supreme Court of India to the contrary, we undertake to made such payment on issue of a demand note by the State Forest Department / Competent authority.


