- on this account. The contractor will be paid for the actual work done at site on the basis of detailed measurements of individual items as per allotted rates.
- 6. All the material used shall be ISI marked/ as per specifications / approved makes as mentioned in the DNIT / subject to approval of Engineer-in-Charge if not mentioned in DNIT. Inspection will be carried out jointly by QC consultant, Engineer-in-Charge and Divisional Engineer (HQ) or their authorized representative not below the rank of Sub Divisional Engineer at the firm's premises before the dispatch of materials as per relevant BIS Code on receipt of inspection offer from the firm. All expenditure of testing would be borne by contractor.
 - The lay out of work can be changed at any stage and no claim in this respect will be entertained.
 - 8. No material shall be issued by GMADA.
 - 9. The rates of 2200 mm clear dia MS pipe (with or without lining, 12 mm thick) in the BOQ are excluding Excise Duty. The exemption certificate in this regard shall be arranged by GMADA from the Competent Authority as per Central excise Notification No. 6/2007 dated 01-03-2007, as the Excise Duty exemption is applicable on this item.
