The detailed procedure for processing is available in the form of video in the said portal. Before uploading, the proposals are to be shown to the Nodal Officer (FCA), TS for vetting. After vetting only, it is requested to upload the proposals under Forest (Conservation) Act, 1980 for diversion of forest land for non-forestry purpose in a complete shape online and furnish the acknowledgement and then submit hard copies to the Nodal Officer.

It is also requested to deposit an amount of Rs.6,000/- in the shape of DD drawn in favour of Joint Secretary, CEFNARM, Hyderabad towards verification and authentication charges of DGPS Survey Data.
