ORDER:

Reports sent from the Tahsildar, Tambaram and Revenue Divisional Officer on the requisition received from Mr. Baskar Rao, Mr. Selvam, Mr. Shanmugaiah and Mr. Elumalai that there is no alternative non forest land is available for their ingress and egress to their Industrial Establishment in S.Nos.38/1,2,3,4 in Kadaperi Village, Tambaram Taluk, Kancheepuram District.

It is stated in the report that Mr. Baskar Rao, son of Venkata Ramaiah purchased 0.85 Acres in S.No. 38/2 in Kadaperi Village, Tambaram Taluk, Kancheepuram District and having a crusher named "SANDHYA BLUE METAL". Further that Mr. Selvam, son of Raja Nadar has purchased 0.87 Acres in S.No.38/3 in the above stated Village & Taluk and having a crusher named "SARASWATHI BLUE METAL".

Likewise Mr. Shanmugaiah, son of Subbaiah and Mr.Elumalai, son of Kadhirvelu having a blue metal named "SAKTHIVEL BLUE METAL" & "KAMATCHI BLUE METAL" respectively in the land in S.No.38/1 leased out to them in Kadaperi Village, Tambaram Taluk, Kancheepuram District purchased by Mrs. Vimala Gupta.

It is stated in the report that they have obtained license from Commercial Tax Department and Pollution Control Board for running their units in S.No.38, and that there is no road but besides their land there is an unmaintained mud road in the reserve forest land measuring to an extent of 11.05.0 Hectares in S.No.39 shown in the Village records as Pulikoradu reserve forest and the extent 110450sq.mtrs.merged in S.No.1 in the Town Survey record. The Tahsildar enclosed the Sale deed, the Village Revenue records, Town Survey Field Register, Field Map sketch. It is shown in the copy of the Field Map register, S.No.1 segregated as Forest land S.No.2 (Old S.No.38/1) 0.3550sq.mtrs belonging to Vimala Gupta S.No.3 (Old S.No.38/2B) 2300sq.mtrs.owned by Baskar Rao, son of Venkataramaiah, S.No.6 (88/3B) 02350 Sq.mtrs belonging to Raja Nadar, son of Ilaya Nadar. Regarding the petitioner's demand, the Tahsildar, Tambaram and the Revenue Divisional officer have sent their report stating that for the ingress and egress for the Industrial Establishment that there is no other land except the mud road in the reserve forest in S.No.39, (Town S.No.1) Kadaperi village, Tambaram Taluk.

As per the Judgement of the High Court of Judicature, Madras, on the writ petitions filed by the above stated individuals, W.P.No. from 11174/2009 to 11177/2009 & M.P.NO.1 to 1/2009 and 2 to 2/2009 dated 14.10.2009 it is hereby ordered to issue a certificate that there is no alternative non forest land is available except the forest land in S.No.1 for the ingress and egress to their Industrial Establishment in S.No.38/1,2,3,4 in Kadaperi Village, Tambaram Taluk, Kancheepuram District.
