The above said B.T. Bill Subject to the following conditions:-

- The Optical Fiber Cable should be laid as per site plan attached and at extreme edge of PWD road land ROW.
- 2. As far as possible Reliance shall carry out the work by using micro Trenching / Horizontal Directional Digging (HDD)/ Horizontal Boring methods so as to minimize damage to the surface and cause least inconvenience to public.
- Reliance shall have to provide barricading, danger light and caution boards at the work sites to ensure public safety.
- Reliance is also expected to execute the works during off-peak times so as to cause minimum inconvenience to the public traffic.
- Any traffic diversion from PWD roads required during the execution of work shall be provided by the work executing contractor at the cost of Reliance.
- 6. Reliance shall lay the cable at the edge of the ROW or at a minimum distance of 15 mtrs from the centre of road and at least 1.5 mtrs below the road surface subject to at least 0.3 mtrs below the drain inverts.
- 7. Reliance shall ensure the safety of existing cables and shall be responsible for any damage to existing cable.

8. Reliance shall make its own arrangement for crossing crossed drainage structure / rivers etc.

9. In case the Reliance wants shifting / repair or alteration of OFC, they will have to inform in writing to the concerned EE of PWD at least fifteen days in advance before starting the actual work.

10. In case of any damage to the essential services i.e. water supply, sewerage system and telecommunication lines, electricity supply etc. it will be the responsibility of the Reliance to get the services restored to their original and satisfactory condition at its own cost.

11. Reliance shall not sell or trade on the area / space available in the ducts without specific permission of GoH.

12. Reliance shall undertake that the cable shall be removed within fifteen days of notice of removal / shifting of cable, if required by the PWD B&R and cost thereof be borne by Reliance.
