

With reference to the above cited subject, it is to inform that the proposal No. FP/OR/ROAD/24576 /2017 for diversion of 176.231 ha Forest Land for project road start Balar Chowk junction at Talcher Km 8.500 of NH 23 proceeding to pitiri junction of NH-23,NH-200 (Talcher -Duburi -Chandikhole ,N.H.-200.) for seeking permission from GOI, MOEF under Forest Conservation Act,1980 again has been received in this office through on line.
