In view of above, it is requested to kindly initiate the process for settlement of claims and rights under Schedule Tribe and Other Traditional Forest Dwellers under Forest Rights Act, 2006 and it is also requested to kindly issue the requisite **certificate in form-II (for nonlinear projects)** towards the settlement of all claims and rights over the proposed forest land falling the villages as specified above along with all compliance report as per above mentioned MoEF letter F.N.11-98-FC (pt.) 05.07.2013 dated 05.07.2013 (copy enclosed for your ready reference as **Annexure-III**).
