उपरोक्त विषयान्तर्गत प्रासांगिक पत्र के क्रम में निवेदन है कि आलौच्य प्रकरण Laying of railway line for private siding for Cement plant में वन संरक्षण अधिनियम 1980 के अन्तर्गत वनभूमि प्रत्यावर्तन में लगाये गये आक्षेपों की पूर्ति निम्नानुसार कर रिपोर्ट सूचनार्थ एवं आवश्यक कार्यवाही हेतु सादर प्रस्तुत हैं।

1	When the kml of proposed CA-NFL land as available on the Parivesh Portal is opened on Google Earth, the kml falls inside Foest Block Parewar according to the forest land boundary available on the website of the Department. The actual position of proposed CA land maybe rechecked vis-a-vis forest block boundary. Kml of either CA land or the forest block boundary on the department website may be suitably rectified.	The KML of the Foerst block boundary has been rectified.
2	The khasra map indicating Forest land boundary and proposed CA land and relevant Jamabandi may be provided.	The khasra map indicating Forest boundary and proposed CA-NFL land and relevant Jamabandhi attached in 4 copies.
3	The CA scheme available in Part II seems to have been not rectified as required by the earlier EDS raised. Point 2 (ii) of the scheme document still mentions DFL instead of NFL.	the required entries in the part II rectified.
4	The CA estimate indicates that 1100 plants per hectare would be planted on the CA-NFL land. There is no afforestation model for non-IGNP areas of Jaisalmer where such density of plantation has been prescribed. It seems the CA estimate is not based on actual Site conditions. The same may be rectified as per CA guidelines of FCA. In	The proposed CA-NFL estimate rectified. On the CA-NFL land 600 plants per hectare will be planted and the rest 500 plants per hectare will be planted on DFL in Forest block Karahi. The required CA-NFL and DFL attached. 	case less than 1000 plants per hectare are proposed to be planted on the proposed CA-NFL land, the remaining may be proposed to be planted on suitable DFL and the CA scheme / estimates / kml may be accordingly rectified on the portal.	
5	It also appears from the Google Earth imagery that some work may have been done earlier on the proposed CA-NFL land. There seems to be a wall/fencing done around the area. The factual position may be ascertained and the proposal may be revisited accordingly in view of the recent amendments made in the Forest Settlement Rules.	The wall constructed earlier is not on the Forest boundary. No work had been done in this area.

नोट :- पूर्व में 7.38 हैक्टर के लिये प्रति पौधा हैक्टर 1100 के हिसाब से 8118 पौधों हेतु क्षतिपूर्ति वृक्षारोपण योजना बनाकर प्रेषित की गयी थी। परन्तु क्षतिपूर्ति वृक्षारोपण हेतु गैर वनभूमि 7.38 हैक्टर में अब 600 पौधे प्रति हैक्टर के हिसाब से 4428 पौधों हेतु CA-NFL एवं 3690 पौधों हेतु CA-DFL कुल 8118 की CA-Scheme बनाकर प्रेषित की जा रही है।
