Subject: - No Objection Certificate (NOC) to the PWD (B&R) for utilizing land of Indri Disty. from RD 53815 to 37420/L and of Nuh Drain from RD 30000 to 33500/R for construction of new road along Indri Disty. and Nuh Drain, for constructing Nuh-Palwal (village Mannaki) to Jogipur-Hathin road (village Tain), from Km. 0 to 5.32 in Nuh District (CM Announcement Code No.22706 dated 23/09/2018).

Reference: - Your office single file U.O. No. 204/S.F. dated 07.02.2019.

As recommended by you vide your letter under reference, No Objection Certificate to the PWD (B&R) for utilizing land of Indri Disty. from RD 53815 to 37420/L and of Nuh Drain from RD 30000 to 33500/R for construction of new road along Indri Disty. and Nuh Drain, for constructing Nuh-Palwal (village Mannaki) to Jogipur-Hathin road (village Tain), from KM 0 to 5.32 in Nuh District is hereby accorded by the Engineer-in-Chief, Irrigation and Water Resources Department, Haryana, Panchkula subject to the following conditions:-


1. The applicant shall furnish requisite charges/fees before execution of work i.e. the processing fee of Rs. 25000/- and Caution deposit of Rs. 10.00 lacs be got deposited from PWD (B&R) for construction of road on the bank of Indri Disty. from RD 37420 to 53815 Left and Nuh Drain from RD 30000 to 33500 Right. 50% of the caution deposit shall be refunded after satisfactory completion of the work and restoration of the Bund at the construction site and the remaining 50% shall be non-refundable and to be kept by the department as security till the works remains in position.
2. Ownership of land of Indri Disty. from RD 37420 to 53815 Left and Nuh Drain from RD 30000 to 33500 Right where PWD(B&R) will construct road, will remain with Haryana Irrigation & W.R. Department, Panchkula. If additional land other than the available Govt. land is required, the same will be arranged/purchased/acquired by PWD (B&R) at their own level.
3. The design section of Indri Disty. from RD 37420 to 53815 Left and Nuh Drain from RD 30000 to 33500 Right will be maintained by PWD (B&R) and will not be disturbed during/after the execution of work.

4. Maintenance of road and protection measures thereon will be taken by PWD (B&R) during construction and for all times to come. Any legal action arising out of this proposal will be taken care of defended by PWD (B&R) at their own cost.
5. The cost for construction of road will be borne by the PWD (B&R) and in case of widening of Indri Disty. from RD 37420 to 53815 Left and Nuh Drain from RD 30000 to 33500 Right is required in future, PWD (B&R) will abide by the directions of the Irrigation & W.R. Deptt. and will not make claim of any type. Further, PWD (B&R) will abide by all other terms and conditions as laid down in the policy approved vide Govt. memo No. 2/175/2011-1IW dated 25.07.2017. The affidavit in this regard be obtained from, PWD (B&R) before start of work.
6. That department reserves the right to withdraw the permission if at a subsequent date it is found that permission is not as per rules or against the interest of Irrigation & W.R. Deptt., Haryana.
7. Drawings be got countersigned from concerned Superintending Engineer of Irrigation Deptt. in lieu of checking Hydraulic Parameters.
8. Before construction of road, consent of land owners adjoining to Indri Disty. and Nuh Drain, if required, may be taken by PWD (B&R) itself & copy of same may be provided to I&WR Department.
9. Any other condition which competent authority deem fit.
10. Before allowing construction of road Indri Disty. from RD 37420 to 53815 Left and Nuh Drain from RD 30000 to 33500 Right above conditions be got obtained on non-judicial paper alongwith amount to be deposited as per Approved Policy Guidelines of I&WR Deptt., Haryana.
