**Notification**

The 10th July 1946

No. 833-VIF-9/46-R.—It is hereby declared that in accordance with an application under section 33 of the Indian Forest Act, 1927 (XVI of 1927), made to the collector of Monghyr by the General Manager, Gidhaur, Parda Estate, P. S. Jamui (district Monghyr), the Government of Bihar is pleased to apply to the forest lands described in the schedule annexed hereto all the provisions of the said Indian Forest Act which are applicable or may hereafter be extended to apply to the reserved forest belonging to Government in the districts of Monghyr and Gaya.

2. The Governor of Bihar is further pleased to declare in pursuance of section 4 of the said Act his intention of constituting the said lands a reserved forest.

3. The Governor of Bihar is further pleased, in exercise of the power conferred by the said section 4, to appoint Mr. Rajkishore Prasad Sinha, no. 1, Sub Deputy Magistrate and Sub-Deputy Collector, to be the Forest Settlement Officer to enquire into and determine the existence, nature and extent of any right alleged to exist in favour of any person in or over any of the said lands or in or over any forest produce to be found therein and deal with the same as provided by Chapter II of the said Act.

4. The Governor of Bihar is pleased, in exercise of the power conferred by section 17 of the said Act, to appoint the Collectors of Monghyr and Gaya to hear appeals referred to in that section in respect of the forests situated within their respective jurisdiction.
