Sub: - Proposal for diversion of 310.110 Ha forest land under Keonjhar Forest Division, Keonjhar for construction of Right Main Canal and Distributary of Kanpur Canal System in Keonjhar District by Executive Engineer, Kanupur Canal Division, Jhumpura of Water Resource Department Govt. of Odisha. (Proposal No - FP / OR / IRRIG / 40827 / 2019, State Serial No - OR-050/2019, dated 06.07.2019).

Sir,

In response to the letter cited above I would like to clarify the points raised by the Principal Chief Conservator of Forests, Forest Diversion and Nodal Officer, FC Act, O/o the PCCF & HoFF, Odisha, Bhubaneswar as follows:-

1. **To make out exact extent of Forest land involved in the project, the plot wise sabik status of the non-forest land involved in the project as of 25.10.1980, authenticated by Tahasildars concerned may be furnished for each village.**
- ❖ We have made out exact extent of Forest land involved in the project, the plot wise sabik status of the non-forest land involved in the project as of 25.10.1980, authenticated by concerned Tahasildars and enclosed in the Diversion Proposal.
2. **It is seen the few plots having Kisam Gramya Jungle in Hal status has not been taken in to account, while computing the forest land involved in the project. (Example Plot No 709, 717 of Khata No 72 of village Basudevpur under Champua Tahasil. Therefore, the detailed list of non-forest land involved in the project may be scrutinized thoroughly and exact extent of forest land may be derived correctly.**
- ❖ Plot No 709 and 717 of Khata No 72 of Basudevpur village under Champua Tahasil is a non-forest land and Hal Kisam comes as Gochar. But it is mentioned as Gramya Jungle by typographical mistake in the land schedule. The corrected plot wise non forest land schedule of Basudevpur village authenticated by concerned Tahasildars enclosed in the Diversion Proposal.
3. **The abstract of non-forest land pertaining to Jajaposi village under Champua Tahasil and Solaguda village under Jhumpura Tahasil involved in the project does not tally with the plot-wise detailed non forest land schedule of those two villages reported to have been involved in the project & furnished in the proposal. Such discrepancy in case of other villages, if any may also be verified once more to avoid future objection.**

- ❖ The area of non-forest land schedules have been verified scrupulously with respect to their abstract and following villages have been corrected as follows-
