

TO WHOM SO EVER IT MAY CONCERN

In compliance of the Ministry of Environment and Forest (MoEF), Government of India's No. 11-9/98-FC (pt) dated 3rd August 2009 wherein the MoEF issued guidelines on submission of evidences for having initiated and completed the process of settlement of rights under the Scheduled Tribes and other Traditional forest Dwellers (Recognition of Forest Rights) Act, 2006 ('FRA' for short) on the forest land proposed to be diverted for non-forest purposes read with MoEF's letter dated 5th February 2013 wherein MoEF issued certain relaxation in respect of linear projects it is certified that 5.247 hectares forest land proposed to be diverted in favour of **"CEO Chhattisgarh Infotech Promotion Society (CHIIPS) Raipur, C.G."** for the laying Optical fiber Cable under Bharat Net Project in Bastar district falls within jurisdiction of Bastar District i.e. Darbha, Bastanar and Lohandiguda tehsil.

It is further certified that :-

- (A) The complete process for identification and settlement of rights under the FRA has been carried out for the entire 5.247 hectares of forest area proposed for division. A copy of records of all consultations and meetings of Forest Right Committee(s), Gram Sabha(S), Sub-Division Level Committee (s), District level committee are enclosed as annexure. **(Not Applicable)**
- (B) The diversion of Forest land for facilities managed by the Government as required under section 3(2) of the FRA have been completed and the Gram Sabhas have given their consent to it; **(Not Applicable)**
- (C) The proposal does not involve recognized rights of Primitive Tribal Groups and pre-agricultural communities. As the purpose of the use of the land in essence is not diverted but only for allowing Chhattisgarh Infotech Promotion Society (CHIIPS) Raipur, C.G. for laying underground Optical Fiber Cable for Bharat Net Project. **(Not Applicable)**
