The Proposed Steel Gas Pipeline will be laid underground at minimum depth of 1.2 meter from existing road top level or ground level whichever is lower and will be laid by open-cut method / HDD parallel to Road and while crossing the road it will be laid at a minimum depth of 1.65-meter existing road top level or ground level whichever is lower and by HDD method or as per directives or as per instructions of MoRTH/NHAI. We assure to restore the job-site land surface to its original condition. The details showing the route of the proposed pipeline shown in the map is attached herewith for your kind perusal.
