In reference of Regional Office (North Central zone) Dehradun MOEF GOI letter No. 8B/HP/01/147/2019/F.C/2072 Dated 12-12-2019 vide which they have pointed out some shortcoming in the proposal folder in respect of above cited subject. In this context we have submitting point wise reply for your kind information and farther necessary action please.

- I. We had already search out the availability of non forest land for the muck dumping sites in Bhandal Panchyat of near to project area but there is no availability of non forest land. Also the joint inspection committee was inspected whole project sites and recommended accordantly. Further it is inform you that the design of muck dumping sites has been prepared accordingly so that there is no requirement to fell the 12 number of the trees coming in various muck dumping sites.
- 2. In Himachal Pradesh of District Chamba as per the revenue department land settlement has yet not been completed. So in revenue measurement minimum scale is I karama which is equal to 1,42mtrs. We have taken 11 karama which is equal to 15.62mtrs to match the requirement of forest department for the transmission line. The necessary correction has been made in the proposed transmission line and revised transmission line in forest and non forest area submitting with the proposal.

While the NOC of Gram Panchyat and FRA proceeding of FRC Jalari of Jalari mohal has already been submitted with the proposal.
