You here by issued NOC on the recommendation of SDO PWD, B & R Punjab Branch Sunam at Sunam-Lehra-Jakhal Road on the following conditions.

1. The applicant will not construct anything in the boundary of Department PWD.
2. The applicant will construct boundary wall from the at the distance of 10 Mtrs from the boundary of PWD and make it sure that any construction will be according to the instruction of PWD.
3. Arrangement of drain be made for disposal of water at your on level so that there will not be any damage to the road.
4. Garbage should not be dumped alongside the road.
5. There will be no parking on the land of road.
6. If in future there is need to wide the road then the owner will construct approached road at his own expenses and will claim anything regarding it.
7. Because NOC is issued before the construction if there is any violation found on checking of instruction of Govt. rules then NOC will be deemed cancelled.

This provisional NOC will be only for passage from Sunam-Lehra-Jakhal Road upto the gate of factory and applicant will be responsible for any construction (Building, Shed, Boundary wall etc) . The applicant will be responsible to obtain the NOC from other departments i.e. Forest, Municipal Committee for any other Department.

While constructing the passage there will be no hurdled of the traffic on road and kept full safety measure of the road. Applicant will be responsible for it. and while construction nor row material/machinery etc will not be stacked on the road side or Brumes.

10. If there is any accident accrued during the construction then the applicant will be responsible for compensation decided by the Judicial Court.

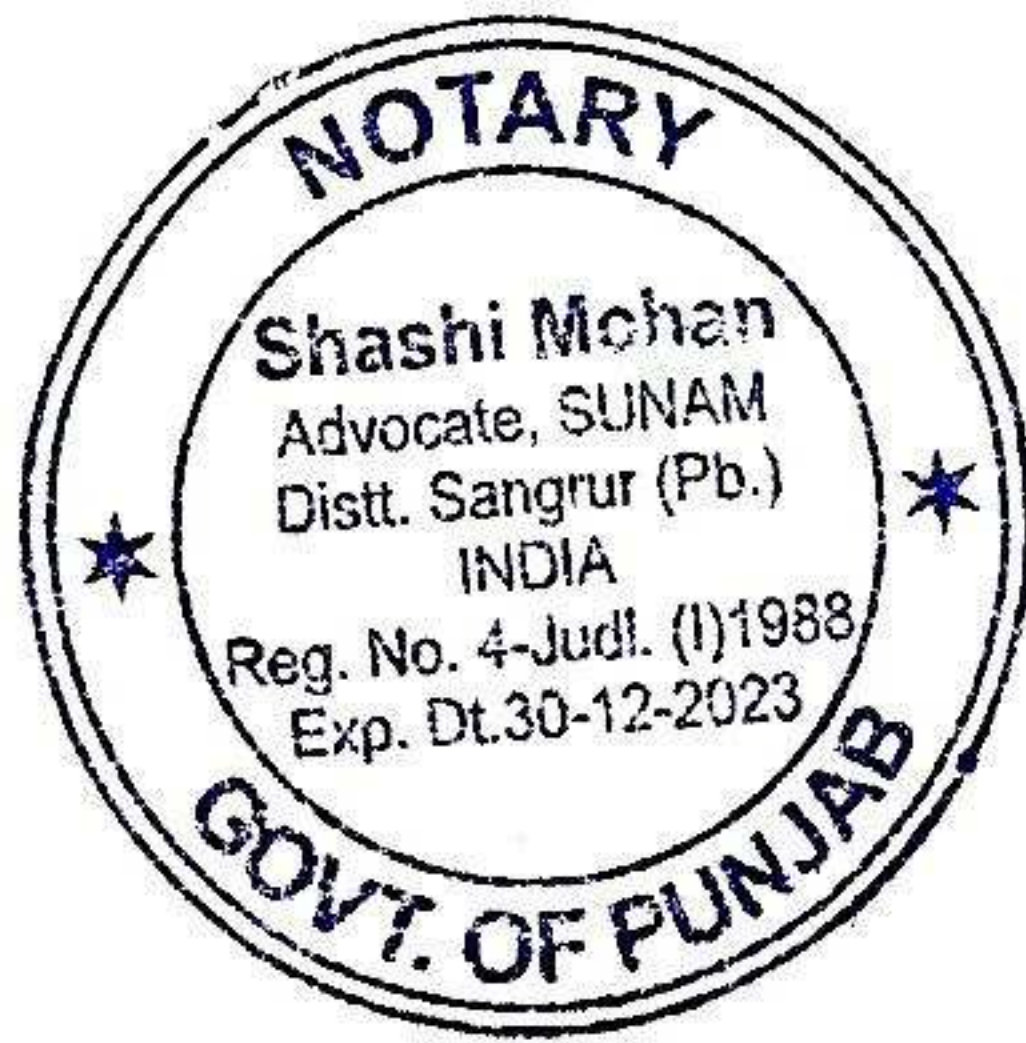
