I invite attention to the subject and references cited, wherein M/s. Singareni Collieries Company Ltd., have informed that they have filed an application under the Forest Conservation Act, 1980 for diversion of 179-83 Ha of Forest Land in Bellampally RF as they have proposed for expansion of existing Shanthikani Mining Lease and requested this office to issue a certificate on the availability of mineral in the area for grant of Mining Lease area.

In this connection, a certificate was issued vide reference 7<sup>th</sup> cited to the General Manager, SCCL, Mandamarri area on the availability of mineral in the area for grant of additional Mining Lease area as requested by them after conducting Joint inspection with the officials of the Forest Department and SCCL.

In the reference 8<sup>th</sup> cited, the General Manager, SCCL, Mandamarri area has informed that the proposed area has been reduced to 177.64 Ha from 179.83 Ha there by increasing the Non-Forest area to 118.42 Ha and Forest area of 177.64 Ha and requested to issue revised certificate. Accordingly, a revised certificate was issued by this office vide reference 9<sup>th</sup> cited.

In the reference 10<sup>th</sup> cited, the General Manager, SCCL, Mandamarri area has informed that as per the guidelines of MoEF & CC, Govt. of India, the Forest Land proposed for diversion has to be authenticated by the Prl. Chief Conservator of Forests (PCCF), Hyderabad. The PCCF, Hyderabad has verified the ETS & DPGS Raw data and communicated the authentication that the Forest area comes under proposed diversion is 178.243 Ha instead of 177.64 Ha. The General Manager, SCCL requested this office to issue a revised certificate about availability of Mineral / Coal in the revised Additional Mining Lease area of 296.06 Hects (178.243 Ha Forest Land + 117.817 of Non-Forest Land).
