Sir, Please refer to your letter No. 14011/RO-VNS/2017/4905 dated 18.12.2017, for issue of provisional NOC for access road permission to the retail outlet in subject.

- M/s HPCL vide letter no. HPC/VRO/BADLAPUR/08 dated 17.01.2018 has submitted additional license fee vide DD no. 374404 dated 17.01.2018 of Rs.12,156/-.
- The above proposal has been examined in this office in light of Ministry's guidelines issued 3. vide letter no. RW/NH-33023/19/99-DO-III dated 24.07.2013 and subsequent clarification dated 06.11.2013, 18.02.2014, 25.08.2014 & 01.12.2014 and Circular No.NH-11014/2/2014-P&M dated 04.11.2016. Based on the drawings, checklist and associated documents as recommended by Regional Officer (CGM), UP-East, NHAI, Varanasi the proposal has been approved 'In principle' by the Competent Authority/Highway Administration in the Regional Office, Ministry of Road Transport and Highways, Lucknow. The provisional NOC is being issued to the proposal, subject to the following conditions:
- The Provisional NOC shall be valid only upon the successful realization of the requisite fee to the Central Govt. account.
- The drinking water and toilet facilities shall be provided at the fuel station. Such facilities (H) shall be accessible to the public round the clock. In order to inform the public about these, a retro reflective display board as per format enclosed at Annex-I shall be installed at the buffer strip in-front of fuel station.
- For drainage, RCC stab culvert with minimum span of 2m shall be provided as per IRC: (iii) SP:13-2004 - "Guidelines for the design of small bridges and culverts". The slab culvert shall be constructed with iron grating of adequate strength in the approaches for drainage of surface water. It must be ensured that outfall of above said culverts shall be connected to nearest drainage facilities available along/across the road.
- The Architect/Consultant shall ensure the video recordings (before and after completion of (iv) construction work) of the site and that the work is done as per approved drawings, failing which action will be initiated to blacklist such Architect/Consultant and to de-energize the

The approval is based on the submissions made by the Applicant as verified by the NHAI. The Applicant is responsible for the details provided in the application. The Ministry is at liberty to verify the authenticity of the documents at any time. Any misrepresentations, omission-or-suppression-of-facts-or-disclosure-of-incomplete facts-detected at-any-stage shall lead to withdrawal of this approval with cost to the applicant.

- Any unauthorized access from the National Highway shall be cut-off and necessary action (w) be taken as per Ministry's guidelines.
- The oil company may construct the access to the proposed fuel station, as per approved drawings at their own cost within 6 months of the issue of this Provisional NOC. After the construction as per approved drawings and the certification by the Project Director, NHAI, PIU, Varanasi along with recommendation of Regional Officer (CGM), UP-East, NHAI, Varanasi that the construction work has been carried out in compliance with the provisions approved, the issue of final formal permission including issuance of signed license deed may be considered. In case the construction is not done in one year of the issue of this provisional NOC, the same shall be deemed to be cancelled, unless renewed by the Competent Authority. The concerned Oil Company would be allowed to energize the fuel station only after the final approval by the Competent Authority.
- The fresh License deed (duly indicating new NH No. along with chainage), in two originals, as per the standard format given in Ministry's circular dated 24th July, 2013, drawn on new stamp paper and duly signed by authorized signatory may be furnished at the time of issue of final permission.
- In view of the above, a copy of drawing (layout and drainage plan) as approved by the Competent Authority, along with the time barred DD no. 378354 dated 21.09.2017 of Rs.10,000/is being enclosed herewith for taking further necessary action.
