का.आ. 149(अ).—केन्द्रीय सरकार ने, राष्ट्रीय राजमार्ग अधिनियम, 1956 (1956 का 48) (जिसे इसमें इसके पश्चात् उक्त अधिनियम कहा गया है) की धारा 3क की उपधारा (1) के अधीन जारी की गई भारत सरकार के सड़क परिवहन और राजमार्ग मंत्रालय की अधिसूचना संख्या का.आ., जो भारत के राजपत्र, असाधारण, भाग ॥, खण्ड 3, उपखंड (ii) में प्रकाशित की गई थी, द्वारा कर्नाटक राज्य के गुलबर्गा जिले में NH150 के कि.मी. 34 से कि.मी.70.9 (यादगीर) तक के भूखण्ड पर टोल प्लाजा के निर्माण, अनुरक्षण, प्रबंधन और प्रचालन के लिए उस अधिसूचना से उपाबद्ध अनुसूची में विनिर्दिष्ट भूमि का अर्जन करने के अपने आशय की घोषणा की थी;

और उक्त अधिसूचना का सार उक्त अधिनियम की धारा 3क की उपधारा (3) के अधीन तारीख "06.09.2018" को "डेक्कन हेराल्ड" और "विजय कर्नाटक" और तारीख "11.10.2018" को " इंडियन एक्सप्रेस " और " संयुक्त कर्नाटक"दोनों में प्रकाशित किया गया था ;

और आक्षेप प्राप्त हुए थे और सक्षम प्राधिकारी ने उन पर विचार कर लिया है और आक्षेपों को अननुज्ञात कर दिया है ; और सक्षम प्राधिकारी ने उक्त अधिनियम की धारा 3घ की उपधारा (1) के अनुसरण में, केन्द्रीय सरकार को अपनी रिपोर्ट दे दी है ;

अतः अब, केन्द्रीय सरकार, सक्षम प्राधिकारी की उक्त रिपार्टे प्राप्त हो जाने पर और उक्त अधिनियम की धारा 3घ की उपधारा (1) द्वारा प्रदत्त शक्तियों का प्रयोग करते हुए, यह घोषणा करती है कि उक्त अनुसूची में विनिर्दिष्ट भूमि का पूर्वोक्त प्रयोजन के लिए अर्जन किया जाना चाहिए ;

S.O. 149(E).—Whereas by the notification of the Government of India in the Ministry of Road Transport and Highways. , published in the Gazette of India, Extraordinary, Part II, Section 3, Sub-section (ii) issued under sub-section (1) of section 3A of the National Highway Act, 1956 (48 of 1956) (hereinafter referred to as the said Act), the Central Construction of Widening to two/four lane with paved shoulders from Km 34.00 to 70.90 (Chittapur Cross to Start of Yadgir Bypass) of NH150 of Gulbarga-Wadi-Yadgir Section (Assistant Commissioner Minividhan Saudha Yadgir) in the district of Gulbarga in the state of KARNATAKA

And whereas the substance of the said notification has been published in "Deccan Herald" and "Vijay Karnataka" both dated 06.09.2018; "Indian Express" and "Samyukta Karnataka" both dated 11.10.2018; under subsection (3) of section 3A of the said Act;

And whereas objections have been received and the same have been considered and disallowed by the competent Authority;

And whereas, in pursuance of sub-section (1) of section 3D of the said Act, the competent authority has submitted its report to the Central Government;

Now, therefore, upon receipt of the said report of the competent authority and in exercise of the powers conferred by the sub-section (1) of section 3D of the said Act, the Central Government hereby declares that the land specified in the said Schedule should be acquired for the aforesaid purpose;

And further, in pursuance of sub-section (2) of section 3D of the said Act, the Central Government hereby declares that on publication of this notification in the Official Gazette, the land specified in the said Schedule shall vest absolutely in the Central Government, free from all encumbrances.
