Subject: Diversion of 0.94 hectares of Forest Land in favour of Executive Engineer, TS Division, HVPNL, Faridabad for Construction of 66KV S/Stn Surajkund Faridabad under forest division and district, Faridabad Haryana applied vide Proposal No. FP/HR/Substation/44046/2020.

The subject cited case was applied vide Proposal No. FP/HR/Substation/44046/2020 on Parivesh Portal for Diversion of 0.94 hectares of Forest Land in favour of Executive Engineer, TS Division, HVPNL, Faridabad for Construction of 66KV S/Stn Surajkund Faridabad under forest division and district, Faridabad Haryana and the hard copies were submitted in the office of DFO, Faridabad vide this office memo no. Ch-141/S-50/Vol-I dated 31.01.2020. Ministry Of Environment, Forest & Climate Change/NR Office Chandigarh has pointed out observation to provide approval of NCRPB for the subject cited case as conveyed vide APFFC (FCA) Panchkula, Haryana office Endst no. D-III 9338/4970-71 dated 24.11.2021.

In view of above, a decision has been taken in the meeting held on 10.03.2022 under the chairmanship of ACS (Power) cum Chairman, HPUs in his chamber with ACS, Forest & Wildlife that in view of latest communication dated 09.03.2022 of DTP, Faridabad vide which final report of Distt. Level Sub Committee that the substation land (measuring 0.94 Hect.) has not been included under the area of NCZ has been sent to Director/Town & Country Planning, Haryana Chandigarh and requested for final approval of state level committee, ACS, Forest & Wildlife directed PCCF to process the case for issue of NOC to HVPNL on reference from HVPNL. The copy of the MOM and DTP letter dated 09.03.2022 is enclosed herewith.

The above clarifications has also been uploaded on the online Parivesh Portal on dated 25.03.2022. It is therefore requested that the case for NOC may please be sent back to Nodal office for issuing the NOC. It is pertinent to mention here that the construction of 66 kV S/Stn. Surajkund Faridabad is under CM announcement and is being monitored at the level of Government of Haryana.
