ORDER:-

The brief facts of this case are that the encroachment Misal No. 25 has been prepared against Sh. Rama Nand and Meena Ram both are S/o Sh. Bali Ram Village Reog PO Bhalaog Tehsil Kumarsain, District Shimla HP during settlement operation for making encroachment upon Govt. Land comprising in Khasra No 695 area measuring 00-30-77 Hectare situated in Mohal Reog Tehsil Kumarsain, Distt. Shimla HP.

In compliance Sub-Divisional Magistrate Kumarsain order and inquiry has been conducted through the Patwari/field Kanungo and it is reported that there exist no encroachment on Khasra No. 695. Sh. Daya Nand s/o Late Sh. Rama Nand (deceased encroacher) and Sh. Meena Ram have stated that they are no more in possession of land in question. After receipt of report from field agency, the case was heard in the court of the undersigned, aforesaid encroacher appeared before the court and stated that they have left the possession of encroachment land many years ago and also produced an affidavit in this regard. The statements in this regard recorded on oath.

In view of above, I am convinced that there is no encroachment in Khasra No. 695 and thus the encroachment Misal No. 25 prepared by settlement department is hereby cancelled. It is further ordered that entry of possession against Khasra No. 695 be recorded as "कब्जा स्वयं तावे हकूक वर्तन वर्तनदारान गुताविक नक्शा वर्तन". The copy of the order sent to the Patwari Jadoon with direction to update and report if in future any encroachment is reported. File to be consigned to record room after due completion.
