Dear Sir,

Your kind attention is invited to the Implementation Agreement (IA) executed on 4th March 2011 with the Govt. of Himachal Pradesh for constructing Kutehr HEP in District Chamba, Himachal Pradesh. As per the HPPTCL approved scheme of Kutehr HEP power evacuation, the transmission lines of 400 kV D/C from the Pothead Yard of Kutehr HEP is to be connected at Tower No 8 (LILO Point) of Lahal –Rajera 400 kV D/C Line of HPPTCL.

As per the revenue records, Forest Land measuring 3.7904 Ha. is essentially required to be diverted (as shown in Check List Serial No 7) under Forest (Conservation) Act, 1980, for nonforestry purpose in favor of JSW Energy (Kutehr) Ltd, Village Machhettar, Post Chanhouta, Teh. Bharmour, Distt: Chamba. 176309, for the construction of the said Transmission line. The complete proposal for diversion of the Forest land as per the guidelines of MoEF, GOI, is being submitted for seeking prior approval please.

It is therefore requested to kindly grand the approval as early as possible so that construction activities may be started for the said transmission line after obtaining statutory/ non-statutory clearances from various departments.
