As per the directions of the forest department vide reference No. 2, herewith we are submitting the following for your perusal and necessary action.

1. The private forest land proposed for diversion in Survey No. 17 of Mollem village has already been acquired by the Public Works Department of Goa, (In this case it is the User Agency ) (Form I & XIV is attached for ready reference). Hence, submission of NOC from the land owner is not applicable.
2. With regard to the private forest land in survey No. 100 of the Darbandora village; this land was granted to landless persons in the year 1976 by the government of Goa. The district administration is working with concerned persons/grantees to revert the land to the government and then issue the No Objection Certificate. As this process is going on for more than one and half year now, it has been decided to drop this parcel of land from the process of diversion and take necessary measures for the smooth running of the project.
3. Further herewith an undertaking is being submitted to furnish the necessary certificate from the District Collector South Goa, as per the provisions of the FRA- 2006. As soon as the certificate is being issued by the District Collector, South Goa, this office will submit the same

As the PWD (NH), Goa is in an advance stage of completing the project your are requested to expedite the process as early as possible.
