In compliance of the Ministry of Environment and Forest (MoEF), Government of India's letter no.11-9/98-FC (pt) 3/8/2009 wherein the MoEF issued guidelines on submission of evidences for having initiated and completed the process of settlement of rights under the Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006 ('FRA', for short) on the forest land proposed to be diverted for non-forest purposes, it is certified that 0.0116ha of forest land proposed to be diverted in favour of **CWC SID, (name of user agency) for Diversion of 0.0116Ha of Forest Land for Installation of Automatic Data Acquisition & Real time data transmission system through Satellite for Rainfall Water Level & Snow measurement at 17th Mile Katao Gurudongmar Lake, Yumesamdong, Dombang, Thangu, Yumthang Valley, Dombang Zero, Lachung, Samdong, Zema and Lachen in North Sikkim by CWC** (purpose for diversion of forest land) in Mangan district falls within jurisdiction of Gurudongmar Lake, Yumesamdong, Dombang, 17th Mile Katao, Thangu, Yumthang Valley, Dombang Zero, Lachung, Samdong, Zema and Lachen village in **Lachung & Lachen** tehsils.

It is further certified that:-

- a. The complete process for identification and settlement of rights under the FRA has been carried out for the entire 0.0116ha of forest land proposed for diversion. A copy of records of all consultations and meetings of the Forest Rights Committee (s), Gram Sabha (s), Sub-Division Level Committee (s) and the District Level Committee are enclosed as annexure 1(a).
- b. The diversion of such division (with full details of the project and its implications, in vernacular/local language have been placed before each concerned Gram Sabha of Forest Dwellers, who are eligible under the FRA;
- c. The each of concerned Gram Sabha (s), has certified that all formalities/processes under the FRA have been carried out, and that they have given their consent to the proposed diversion and the compensation and ameliorative measures, if any, having understood the purpose and details of proposed diversion. A copy of certificate issued by the Papon, Lachen Dzumsa village (s) is enclosed as annexure I (a).
- d. The discussion and decisions on such proposals had taken place only when there was a quorum of minimum 50% of the members of Gram Sabha present.
- e. The diversion of forest land for facilities managed by the Government as required under section 3 (2) of the FRA have been completed and the Gram Sabha have given their consents to it.
- f. The rights of Primitive Tribal Groups and Pre-Agricultural Communities, where applicable have been specifically safeguarded as per section 3 (1) (e) of the FRA...




