It is informed that ETS & DGPS/ GNSS Survey data, of the forest land proposed for diversion for laying of OFC pertaining to Jayashankar-Bhupalapally district furnished by the M/s Reliance Jio Infocomm Ltd vide reference 1st cited cited has been verified, as per priority informed by User Agency and the same was communicated vide reference 2nd cited.

It is informed that the balance ETS & DGPS/DGNSS data furnished by User Agency in various districts has also been **verified and same is accepted, subject to certain conditions**. It is informed that the proxy RF boundaries depicted on topomaps are used for ascertaining the entry & exit points of alignment with RF. The division boundaries are ascertained with the help of available records. The extents of alignment passing through notified forests are estimated as follows:

The APCCF, Karimnagar, CCFs Medak, Rangareddy, Warangal; CFs/FDPTs, Amrabad Tiger Reserve, Achampet and Kawal Tiger Reserve, Nirmal; District Forest Officers Jayashankar-Bhupalapally, Medak, Karimnagar +Sircilla, Mahabubnagar, Nalgonda, Vikarabad, Sangareddy, Mancherial, Peddapally; Forest Divisional Officers Bhupalapally, Nalgonda, Mancherial are being requested to verify absolute location of Points in field; and also to include/ delete areas, if required, after verification, including the status of Protected Areas and their eco-sensitive zones.

In this regard, UA is informed that piece meal proposals are being submitted in a single district/division, which is not permissible. Hence, User Agency is once again requested to assess the entire requirement and prepare the phased program for submission of proposals. Accordingly, User Agency is requested to prepare the division-wise proposals along with the justification for diversion of additional areas in a complete shape in Forest (Conservation) Act, 1980 format for RF areas and Forest (Conservation) Act, 1980 & Wildlife (Protection) Act, 1972 format for the areas falling in Protected Areas & their eco-sensitive zones requiring Environmental Clearance, wildlife corridors etc. and to upload the proposals online, obtain acknowledgement and to submit the proposals in a complete shape along with all necessary documents/information along with the acknowledgement. The total requirement of forest land shall be assessed for entire State as called for above and submitted alongwith the phased program for processing of proposals.

Further, User Agency is also requested to observe the base station readings by keeping it over the SOI GCP to which the points are tagged for SOI GCP locations Ramayampet, Gambhiroapet, Mahamadabad, Mancherial in due course of time to assess affect of tagging of SOI GCP with various observation times and baseline distances, as the observation time is less than 6 hours at these locations.

M/s Reliance is requested to pay an amount of Rs.70,500/- (Rupees Seventy Thousand Five Hundred Only) towards verification and authentication of ETS & DGPS/GNSS data in the form of a demand draft drawn in favor of "Joint Secretary, CEFNARM".
