1 Project details:

- (i) Short narrative of the proposal and project/ scheme for which the forest land is required.

The name of the project is "Rural connectivity road (RCR) from SPWD Road to Chumlok Omchu". This will be a very important road and will be the life line of people residing this area. This road is 8.86 Kilometer long and connects villages like Omchu, Padam, Chumlok and Omchu Secondary school. The entire village depends upon agricultural produce to run their livelihood. There is no road connectivity for these villages and hence the Government has decided to connect these villages by providing/constructing a rural connectivity road funded by PMGSY and has been sanctioned by the concern Ministry.

Considering the location of the villages to be covered geographically, this is the only suitable road alignment involving minimum area of forest department.


