Dear Sir,

With reference to the above letter dt. 07.03.2017 issued from MoEF & CC, Regional Office Bhopal for the subject matter, please find below the point-wise compliance for your kind consideration and recommendation for granting in-principal permission at the earliest possible.

- 1) Please find attached girth class wise details of trees to be felled in English language as **Annexure-A1 to A18 (Total pages 18)**.
- 2) The format for issuing FRA certificate issued by MoEF & CC, Govt. of India Vide F.No. 11-9/98-FC (pt) dt. 05.07.2013. Further MoEF&CC, Govt. of India also issued a direction for issuing FRA Certificate vide even no. dt. 28.10.2014, which has also circulated to all the States and respective Collectors. Based on this direction dt. 28.10.2014, Collector Kachchh had issued FRA Certificate, which should be accepted.

However, as MOEF&CC regional office has asked to provide FRA Certificate in prescribed format, we again requested to Collector office Kachchh for issuing revised FRA Certificate. Collector officials argues on the same line as state above. However, based on our humble request they have issued revised FRA certificate in prescribed format.

FRA Certificate in prescribed format is attached herewith As **Annexure-B**.


- 3) GSPL has examined the alternate routes to avoid reserved forest and details of route examined with reason for finalizing the route, has been attached with the proposal at respective location. However same is once again attached herewith as **Annexure-C1 to C2**.
- 4) Site inspection report for DCF, Exten Division Bhuj and DCF Kachchh East Forest Division, Bhuj has already been attached with the proposal and same is also uploaded in the portal though same is attached herewith as **Annexure-D1-D2**.

- 6) Part-V of the project uploaded in portal. Copy of the same attached herewith as **Annexure-F.**
- 7) KML file for proposed diversion area and CA area has been uploaded in the portal and same is attached herewith in CD (**Annexure-G.**).
- 8) Details of CA area, including total land bank, and balance land bank is attached herewith as **Annexure-H.**
