The proposed project will be laid underground along the road and within the RoW for laying of 132 KV Underground Power Cable in forest stretch as per MoEF &CC guideline dated 12.12.2017. The power cable line in NH utility corridor will pass from location No-87 in Village Topadihi to location No-92 in Village Nuagaon (length 3.013 Km) in Keonjhar district and from location No-106 in village Rengalbeda, through Kasira & Kusumdihi villages in Bonai forest division of Sundargarh District( Length 3.340 km along the ROW of NH-520 + 0.398 KM along the RoW of the approach road that is from NH-520 to Kamanda Steel Plant of M/S Rungta Mines Ltd). In Kusumdihi Village the underground cable will finally pass through the ROW of the approach road (diverted 0.28 Ha forest land) from NH-520 to Kamanda Steel Plant of M/S Rungta Mines Ltd .

(viii) Brief note on vulnerability of the forest area to erosion	The proposed project will be laid underground along the road and within the RoW and will require RCC trench (1mtr width x 1.5mtr depth) along the NH-520 utility corridor (6.353 Km) and through the road that has been constructed by the user agency from NH-520 to Kamanda Steel Plant of M/S Rungta Mines Ltd (0.398km) for the stated purpose. The proneness of the site to soil erosion is negligible. Nonetheless, the Project Proponent has undertaken to make good the soil following completion of the work.
