All the statutory requirements under law have been fulfilled. The Petitioner Companies complied with all the directions given by this Tribunal. The Petition came up for hearing before this Tribunal.

For the purpose of considering and approving without modification, the Scheme of Amalgamation between M/s. Samiran Realties Limited, the Transferor Company, by transferring and vesting operation with M/s. Shubh Realty (South) Limited, the Transferee Company.

Upon perusal and hearing Shri. CIBI Vishnu and Shri. Pawan Jhabakh, the Learned Counsel for the Petitioner

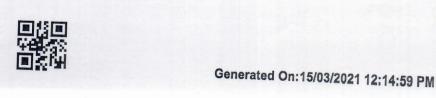
