The KML file has been rectified to make the file Reply of S.No.-1: consistent with joint inspection report. Furthermore, in regard of existing bridle path, it is clarified that this path is less than 1.5m wide. Moreover, this path can't be converted to motorable road even if it widened, as it is in very steep slope with gradient exceeding more than twice the permissible maximum gradient allowed as per technical specifications. Elevation difference between starting point of bridle path & village is 75-80m approximately.
