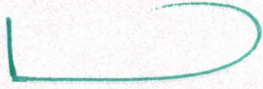
As per the letter dated 27.03.2023 mentioned under reference EDS has been received from the Chief Conservator of Forest, Forest Circle, Nahan.

In this regard, it is submitted that vide this office even file letter No. 13909 dated 15.03.2023, the desired information has already been supplied by this office to your office. However, it is once again submitted that the construction work of the road from Bhogpur to Simbalwala was **initially started by Gram Panchayat concerned in the year 1990**. This department/user agency has no record of the locals/officials involved in the matter. Later on, **formation cutting of this road was completed by the HPPWD/User Agency during 2001-2002 only.**

Moreover, as per your office direction dated 04.03.2023, the names of Executive Engineers and Assistant Engineers posted in this Division/User Agency during the period 1990 to 2001-02 have also been supplied vide this office letter No. 13909 dated 15.03.2023 (Copy enclosed). **Period of their posting in this Division has also been clearly mentioned against their names.**

Sir,

As per the letter dated 20.02.2023 mentioned under reference, EDS has been received from the Integrated Regional Office, Shimla in which name of the staff posted during the period of 1990 to 2001-02 in this Division has been sought.

In this regard, it is submitted that the construction work of the road from Bhogpur to Simbalwala was started during the year 1977 as a footpath track by the Gram Panchayat concerned. The road construction was initially started by the Gram Panchayat in the year 1990 probably in a length of nearly 200 mtrs. & later its formation cutting was completed by the HPPWD during 2001-2002. It is further submitted that subject cited FCA violation case has been listed in approval to cases of construction of road in compliance of directions passed by the Hon'ble High Court H.P. on 08.08.2013 and 05.09.2013 in CWP No. 5600 of 2012 a/w CWP No. 9797/2012 and COPC No. 56/2009. The Hon'ble High Court of H.P. has also given the orders to regularize 2183 roads including this road which has already been constructed in violation of the provisions of FCA, 1980. The list of roads in Nahan Division given by HPPWD to Hon'ble High Court of Himachal Pradesh constructed in violation of FCA, 1980 has already been submitted to your office vide this office even file letter No. 12224 dated 19.11.2022.

Since, the violation in this case has been directed to regularize by the Hon'ble High Court of HP, hence, in view of this department there is no need to take any action against the officials involved in construction of this road, as it will amount to contempt of Hon'ble High Court's directions. Moreover, this formation cutting in this road was carried out by HPPWD only during the year 2001-02 and before that this Department had no interference in the said road. However, as per your office direction dated 04.03.2023, the names of Executive Engineers and Assistant Engineers posted in this Division during the period 1990 to 2001-02 are as under:-
