

Dear Sir,

We refer to your application dated 1.6.2005 for the award Retail Outlet dealership at the above location and the subsequent interview held at our Aonla Office on date 3 o 2005

Please be informed that by this letter of intent, we propose to offer you a Retail outlet dealership at SHAHBAD, Distt. RAMPUR, State U.P. on the following terms and conditions:

- 1 (a) For enabling you to operate the dealership said above, we will develop the Retail Outlet at SHAHBAD, Distt. RAMPUR, State U.P. as per Co. Policy and provide the same to you.
 - (b) Working capital, as may be determined by the Corporation at its sole discretion to be utilized only for the purpose of taking delivery of MS/HSD/Lubs from the Corporation to maintain supply.

The above working capital will carry interest @ 11% per annum payable monthly from the date of disbursement of the working capital by the corporation.

The aforesaid working capital along with the interest mentioned above will be repayable by you in 100 equal monthly installments commencing from the 13th months commissioning of the dealership.

2. For the facilities that may be provided by the Corporation as aforesaid, we will recover from you license fee as may be decided by the Corporation and applicable to you from time to time. At present, the license fee recoverable is Rs. 43/- per KL for MS and Rs. 36/- per KL for HSD.

- 3. The corporation will not be held liable for any loss or damage on account of delay that may be caused in providing you the facilities mentioned above whatever may be the cause of such failure or delay.
- 4. You shall not induct any partner(s) in case of individual (s) nor make any changes in the constitution of the partners, as existing at the time of application and shall give an undertaking to this effect.
- 5. It will always be a basic condition for the award of retail outlet dealership that you shall operate the dealership personally full time and you will give us a written undertaking to this effect and shall not assign or part with the same to any other person(s).
- 6. You will be, notified by the corporation, in writing, after the facilities mentioned above are made available and are ready for commissioning the dealership. Immediately on receipt of the above notice from the corporation, you shall, within a period of two months, comply with the following requirements and produce proof thereof to our satisfaction.
 - a. You have obtained each and every license necessary for operating your dealership as may be required under any central / state govt. / municipal or local authorities for the time being in force; and
 - b. You have resigned from your employment if you are employed, and obtained the letter of acceptance from your employers.

Please note that your failure to comply with the requirements mentioned in (a) & (b) above will entitle the Corporation to withdraw this letter of intent without making any further reference to you, purely at your own risk.

- 7. You will have to shirt your residence to the above location i.e. SHAHBAD. Distt. RAMPUR, in order to effectively operate the dealership and give us a written undertaking to this effect.
- 8. This letter of intent will stand automatically withdrawn and cancelled on the happening of any of the following events:
 - a. In case you or your close relatives like spouse, unmarried son(s) and unmarried daughter(s) receive or have received a letter of intent for any other dealership or distributorship from our company or any other oil company either in your individual capacity or in partnership with any other individual(s).
 - b. If it is found that you have suppressed and / or misrepresented any material facts in your application.
